2021 | Lewisville Charter Election

Lewisville City Council has called a Charter Amendment election to be held Saturday, May 1, 2021, so voters can decide on four Propositions dealing with potential governance changes.

Voters will be able to vote Yes or No on each proposition. A majority of “yes” votes is required for a proposition to pass.


The May 1 ballot also includes the Mayor and two City Council positions.

Proposition A

Should the charter be amended to provide that if, prior to January 1, 2023, the city makes an annexation that increases the geographic size of the city by at least eight percent, the size of the city council will be increased from a mayor and five (5) councilmembers to a mayor and six (6) council members and the number required to constitute a quorum and to transact business will be increased to reflect the addition of one councilmember?

Proposition A details

Under this proposition, the City Council would be increased to six members plus the mayor if the planned annexation of Castle Hills takes place before Jan. 1, 2023. The mayor still would vote only to break a tie. The number of members who would have to be present to conduct business (the quorum) would increase from three to four. Lewisville City Council has consisted of five members plus the mayor since municipal incorporation in 1925.

Proposition A details

With a current population of about 105,000 and a population of about 120,000 after annexation, the ratio of Council members to residents would remain similar. The six City Council seats would be assigned to residential districts, as approved by voters in 2017. Candidates would have to live within the designated district, but all positions would still be voted on at-large (by all eligible voters).

Proposition A details

The change in Council size would not take effect until future annexations added at least 8 percent to the city's total land mass. This is most likely to be if and when the Castle Hills development is annexed into Lewisville. This currently is planned for December 2021. There would be no change made if annexation were not completed by Jan. 1, 2023. Castle Hills voters will not be eligible to vote in Lewisville elections until after annexation (so not until May 2021 if the proposed annexation schedule holds).

Proposition B

Should the charter be amended to eliminate provisions relating to the budget process that are covered by or are inconsistent with state law?

Proposition B details

If a provision of the City Charter differs from Texas law, the state law requirements supersede the charter. This can happen over time as new state laws are adopted. Multiple changes to state law, including several during the 2019 legislative session, create requirements for the city's budget process that are different from requirements of the City Charter. This proposition would remove or amend charter provisions that are covered by or inconsistent with state law in order to reduce any possible confusion.

Proposition B details

Specific changes to the City Charter would include:

Section 9.02 – Preparation and submission of budget.

Removing the required time window for the City Manager to submit a proposed budget to the City Council. This timeline is now addressed in state law.

Section 9.06 – Notice of public hearing on budget.

Removing the required timing for giving notice of a public hearing on the proposed budget. This is now addressed in state law.

Proposition B details

Specific changes to the City Charter would include:


Section 9.07 – Public hearing on budget.

Removing the required timing for holding a public hearing on the proposed budget. This is now addressed in state law.

Section 9.11 – Effective date of budget; certification.

Removing the requirement that printed copies of the budget be made available and adding language that requires the budget be posted on the city's website.

This is consistent with changes in state law.

Proposition C

Should the charter be amended to eliminate the requirement that residents of the city who serve on the city planning commission own real property?

Proposition C details

The City Charter currently requires that members of the Planning & Zoning Commission own real property within the city, in addition to residency requirements. Residents are not required to own property in order to serve on any City Council or any Council-appointed board other than the Planning & Zoning Commission.

Proposition C details

This requirement means residents living in rental properties are not eligible to serve on the Planning & Zoning Commission. Including apartments, more than half of Lewisville's residential households are rental properties.

This proposition would remove the requirement for a Planning & Zoning Commission member to own real property. Members still would be required to live in Lewisville.

Proposition C details

The specific change to the City Charter would be:

Section 8.04 – Planning commission membership.

Removing the words “and own real property therein.”

Proposition D

Should the charter be amended to clarify the role of the city manager by deleting a provision giving the city council authority to administer city departments?

Proposition D details


The City Charter assigns a list of 22 specific powers to the City Council. The Charter also creates a position of City Manager to be appointed by the City Council and serve as the “chief administrator and executive officer of the City.” This establishes a Council-Manager form of government in which the elected City Council sets policy and approves the budget, while a professional City Manager is hired by the City Council to implement those policies and manage day-to-day operations.

Proposition D details

One power assigned to the City Council includes the ability to “establish, create, consolidate, or abolish administrative departments” and “distribute the work of divisions.” Historically, the City Council has left that authority to the City Manager, who as chief administrator already has the authority to hire and supervise department directors. There is no record that this power has even been exercised by the City Council since the City Charter was first adopted in 1963.

Proposition D details

This proposition would remove this City Council power, leaving the other 21 powers unchanged. The specific change to the City Charter would be:

Section 3.07 – Powers of the city council.

Removing item (b), which states “Establish, create, consolidate, or abolish, administrative departments and distribute the work of divisions.”




