A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION HELD IN THE CITY OF LEWISVILLE ON SATURDAY, MAY 3, 2025, TO ELECT CITY COUNCIL MEMBER PLACE NO. 4, CITY COUNCIL MEMBER PLACE NO. 5 AND CITY COUNCIL MEMBER PLACE NO. 6; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is now necessary to declare the results of such General Election and the candidates that received the majority of the votes cast for the particular places listed;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:

SECTION 1. Of the candidates listed in Council Member – Place No. 4 on the ballot, no one received a majority vote of the ballots cast in said election. Therefore, in accordance with Section 5.05 of the City of Lewisville Home Rule Charter, a runoff election is hereby declared necessary to fill Place No. 4 on the City Council, and the runoff election will be ordered by separate action of the City Council.

that a total of persons voted in the General Election held on Saturday, May 3, 2025.
