The proposed boundaries include an additional approximate 53.05 acres generally located south of SH 121 and Business 121 and being wholly located within the ETJ of the City. This ordinance also amends the Project and Finance Plan to update project costs and zone reimbursements including the acquisition of park and open space land, and to include economic development authority.



- "Fiscal Recovery Funds" or ARP

CITY ALLOCATION AND GENERAL SPENDING CATEGORIES

- \$19.54 Million
 - \$9.77 Million already received
 - Balance expected June 2022 "no earlier than 12 months from the date of the first payment"
- Allowable Uses Four Broad Categories
 - (A) Respond to or mitigate public health emergency with respect to Covid-19 or its negative economic impacts
 - (B) Premium pay for essential workers
 - (C) Replace lost revenue
 - (D) Investments in water, sewer, or broadband infrastructure
- Encumber (obligate) funds by December 31, 2024, and total spend-down by December 31, 2026

ALLOWABLE USES - CATEGORY A

- Supporting the public health response
 - Mitigating the impact of Covid-19
 - Medical expenses
 - Behavioral healthcare
 - Public health resources
- Very similar to the allowable uses found in CARES funding
 - Vaccination programs, PPE purchases, investment in public facilities

ALLOWABLE USES - CATEGORY A

- Addressing the negative economic impact from Covid-19
 - Assistance to individuals and households
 - Small business support
 - Recovery of impacted industries (tourism, travel, hospitality)
 - Rehire public sector staff
- Wide range of options for providing assistance in this category

ALLOWABLE USES – CATEGORY A

- Serving the hardest hit communities and families
 - Low-income families and communities of color demographics disproportionately impacted
 - Addressing health disparities
 - Investing in housing and neighborhoods
 - Addressing educational disparities
 - Promoting healthy childhood environments
- Support additional services provided within a Qualified Census Tract (QCT) or to families living within a QCT

ALLOWABLE USES - CATEGORY B

- Providing premium pay for essential workers
 - Identified specific groups as essential workers, such as...
 - Staff at nursing homes
 - Workers at farm, food production facilities, grocery stores, and restaurants
 - Public health and safety staff
 - Paid directly to employee or through grants to private employers
 - Emphasis to prioritize premium pay for lower income workers
 - Retrospective application "both permitted and encouraged"

ALLOWABLE USES – CATEGORY C

- Replacing lost public sector revenue
 - "Use of FRF to continue to provide valuable public services"
 - Treasury has developed a standard methodology to calculate the reduction in revenue
 - GFOA template incorporating Treasury standards
 - Calculation indicates revenue loss by the City \$11.65 million
 - Presumption that any reduction in revenue is due to Covid-19 health emergency
 - **Broad** latitude to use funding to support government services
- Government services can include, but are not limited to, maintenance of infrastructure or paygo spending for building new infrastructure, including roads, the modernization of cybersecurity, health services, environmental remediation, school or educational services, and the provision of police, fire, and other public safety services

REVENUE LOSS CALCULATION

- Steps in calculating revenue loss
 - Determine Base Year Revenue (FY2019)
 - Determine Growth Rate (standard growth adjustment or City's 3-year average)
 - Calculate "Counterfactual" Revenue for 2020 (base year revenue x growth rate)
 - Determine Actual Revenue for 2020
 - Difference is amount of revenue loss
