Thank you for the opportunity to provide service to the City of Lewisville residents and commercial customers, we are looking forward to a long partnership.

The contract allows for an annual price increase based on the CPI Garbage and Trash index June 2023 and June 2024 the calculation (shown below) yielded an increase of 3.75%, per the agreement 5% is the maximum in one year with 15% in four years, based on the previous 3 years we are requesting 3.6% increase for 2025. New rate sheet marked 3.6 draft is attached for your review and will be implemented after verified by staff and voted by Council effective January 1, 2025.
