Item B1: Approval of Minutes

2. Public Hearing: Consideration of a Special Use Permit for Automotive Repair (Minor); on Approximately 1.5871-Acres Tract, Legally Described as Lot 9, Block A, Fairway Business Park; Located at 1504 Eagle Court, Zoned Light Industrial District (LI); as Requested by Texas Star Automotive Services, on Behalf of AIP Eagle Court, LLC, the Property Owner.
