Approval of a First Amended and Restated Economic Development and Utility Participation Agreement Between the City of Lewisville, Old Town Lewisville Tenant I, LP, and Old Town Lewisville Tenant II, LP, and Authorization for the City Manager, or Her Designee, to Execute the Agreement.

(Agenda Item G-5)

On December 18, 2023, the City Council approved an Economic Development and Utility Participation (EDUP) Agreement with Old Town Lewisville Tenant I, LP, and Old Town Lewisville Tenant II, LP (the "Developer"). The purpose of this agreement was to facilitate the construction of The Standard at Old Town, a two phase, 600 unit affordable multifamily housing project located at approximately 701 East Main Street. The project is owned by the Lewisville PFC and leased to the Developer. Since the original agreement was executed, City staff and the Developer have more specifically identified the needs for sanitary sewer capacity and a regional detention solution to support future development in Old Town. This new agreement makes several key changes: (1) it establishes a not to exceed reimbursement amount of \$2,000,000 for utility costs, with an additional \$350,000 available for potential price increases subject to City Manager approval (while these costs were anticipated in the original agreement, the new agreement provides more specifics and sets a maximum amount); (2) the Developer will invest an additional \$2,000,000; (3) the project commencement deadlines for Phase I and II have been extended due to easement negotiation delays; and (4) the City will provide a \$70,000 grant, a waiver of Phase II, and reimbursement of Phase I engineering site plan fees (estimated \$102,632) in consideration for additional investment in the project and acquisition of the easements necessary for construction.

The North Central Texas Council of Governments (NCTCOG) Regional Emergency Preparedness Planning Council (EPPC) is composed of elected officials from participating cities and counties. Old Town Public Infrastructure Needs

City Council Meeting
10.20.2025

Why New Public Infrastructure is Essential

- The properties east of Main Street, north of Business 121 and west of Valley Ridge do not have access to public sanitary sewer.
- These same properties are currently served by septic systems and a private lift station.
- Private septic systems and lift stations are regulated by the TCEQ, but inspections and permitting are left up to local government. Owners often do not maintain these systems. City staff does not inspect these systems unless there is a complaint. Permitting is provided through Denton County. When one of these systems fail, it may not become apparent for an extended time. The existing private lift station has had multiple operational problems over the years due to non maintenance.
- The storm sewer systems underneath College Street and Valley Ridge Blvd. are only sized for a 25-year storm event. Current development standards require storm drains to be designed for a 100-year event.
- The existing detention pond on the DCTA property is only sized to handle storm runoff from the DCTA property and is proposed to be removed when the DCTA site is redeveloped.

Original Economic Development and Utility Participation Agreement

The original Economic Development and Utility Participation Agreement (“EDUP Agreement”) with Old Town Lewisville Tenant I and II LP (the “Developer”) established several key provisions regarding utility capacity and infrastructure needs on the east side of Old Town:

- Anticipated Infrastructure Needs: The agreement acknowledged the need for increased sewer capacity and regional detention.
- Sewer: The City was required to provide the Developer with design parameters for the necessary sanitary sewer capacity for the property and for the future build-out of the surrounding area.
 - Oversizing: The City committed to reimbursing 100% of the oversizing cost, though a specific dollar amount was not identified in the agreement.
 - Sewer Line Extension: The agreement stated that if the City's design parameters required a sewer line extension, a separate agreement would be necessary, but no further details were specified.
- Regional Detention: The agreement included a commitment for the City and Developer to collaborate on a solution to the detention issue. However, because the area had not yet been studied, no further details on the solution were provided.

First Amended and Restated Economic Development and Utility Participation Agreement

The Developer and City staff have collaborated to determine the necessary sanitary sewer capacity required to accommodate future build-out on the east side of Old Town.

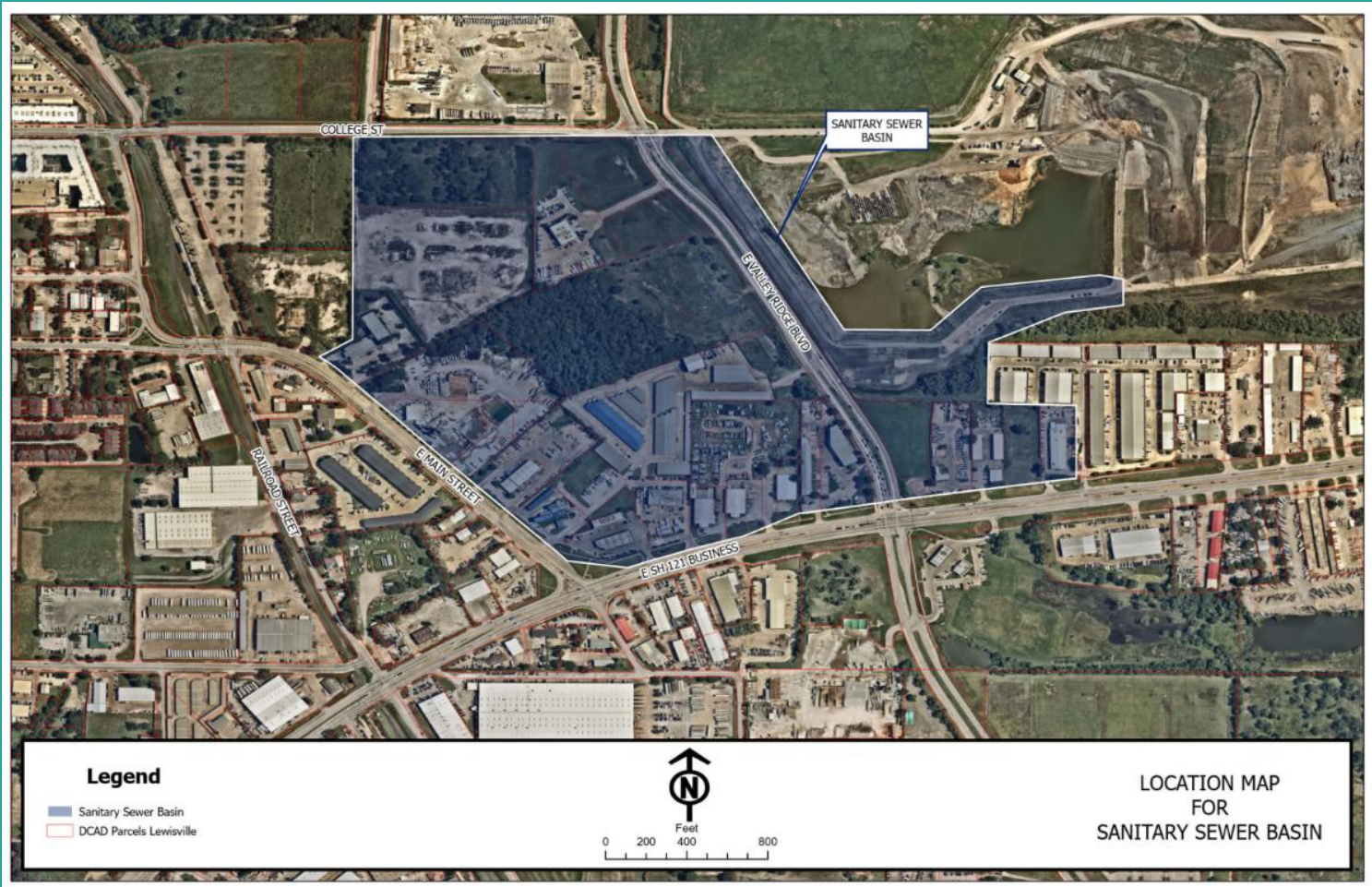
Sewer extension and oversizing are required. The total cost is approximately \$4.3M (\$3.1M for oversizing and \$1.2M for extending):

- The City will contribute \$2 million for actual costs (City Manager may approve up to an additional \$350,000).
- Although the original agreement stipulated that the City would cover 100% of the costs for the oversizing and also participate in the extension, the Developer has committed to a \$2.3 million contribution. This amount would be reduced to approximately \$2 million if the City provides the additional \$350,000.

This approach was chosen because it is faster and more cost-effective for the Developer to construct these improvements rather than for the City.



Sewer Expansion - Properties Benefitted

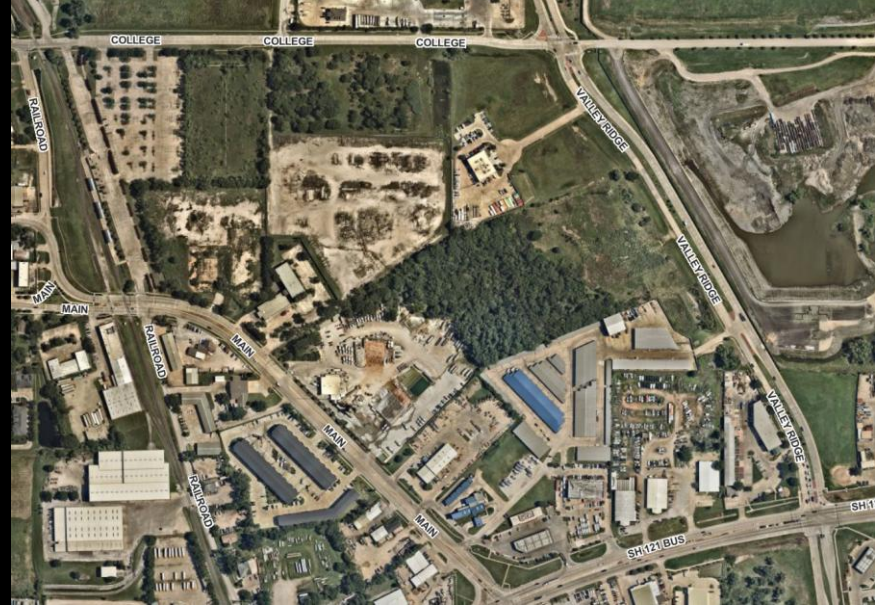


Regional Detention

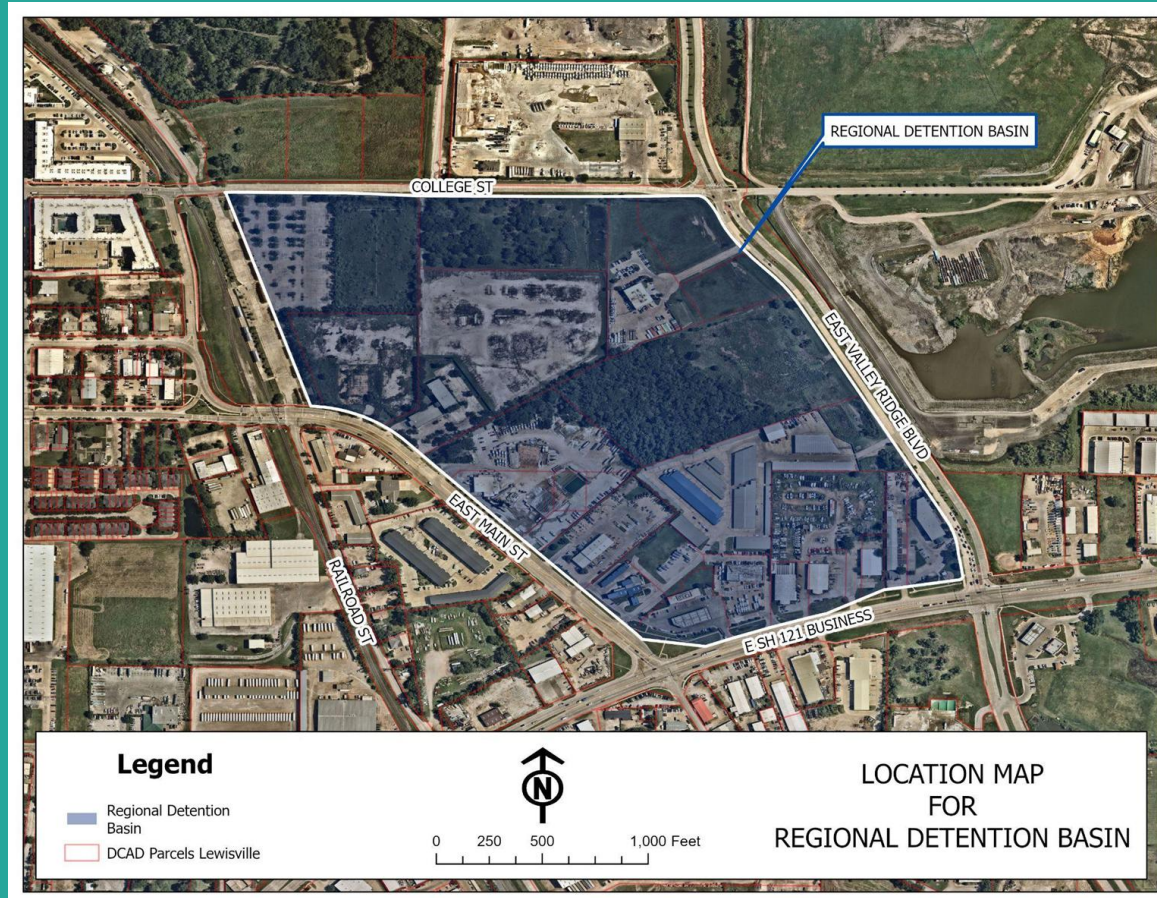
Regional detention is required to enable successful development in the area, including DCTA's anticipated Transit-Oriented Development.

City staff has determined that approximately 2 acres is needed in this area for detention or retention.

The Developer has agreed to participate in the design to ensure that there is capacity not only for the project, but for entire east side of Old Town.

Natural Lewisville

Focus: Environment, sustainability, and resilience

- **Protecting and expanding natural assets**

Preserve wildlife areas, enhance tree canopy and shaded trails, address flooding and trash in natural areas.

- **Building resilience in infrastructure and energy**

Prepare for power outages and extreme weather through renewable energy and emergency systems.

- **Preparing for climate and weather-related events***

Community concern about heatwaves, winter storms, and power reliability.

*Overlaps with Safe Lewisville





Growing Lewisville

Focus: Economic prosperity, job creation, opportunity, and infrastructure

- **Revitalizing corridors and aging centers**
Focus on SH-121B, Vista Ridge Mall, and underused retail areas.
- **Supporting small businesses and job growth**
Encourage entrepreneurship and attract higher-paying jobs.
- **Balancing growth and housing options***
Promote diverse housing types without overburdening infrastructure.
- **Living has become less affordable to the average resident**
Rising costs of housing, goods, and living threaten inclusivity.
- **Investing in the next generation**
Strengthen schools, job opportunities, and local businesses for long-term prosperity.

Connected Lewisville

Focus: Mobility, transportation, and physical connections/access

- **Improve safety along regional thoroughfares**
Address traffic congestion, safe crossings, and pedestrian access.
- **Expanding walkability and safe connections to local destinations**
Improve sidewalks, trails, and transit to reduce car dependence.
- **Retaining free and accessible thoroughfares for existing and future residents**
Preserve equitable access; concerns about tolls and affordability.
- **Growing strain on existing infrastructure**
Rapid development perceived to be outpacing roads and utilities.





Safe Lewisville

Focus: Public safety and emergency response

- **Improving public security and community perception**
Calls for enhanced beautification, better lighting, visible policing and mental health support.
- **Preparing for climate and weather-related events***
Emergency response being prepared for helping the community during heatwaves, winter storms, and power outages.
- **Enhancing mental health services**
Providing access to additional support related to mental health.

*Overlaps with Natural Lewisville





Engaged Lewisville

Focus: Communication, civic pride, inclusion, and community outreach

- **Preserving and celebrating Lewisville's sense of identity**
Maintain small-town feel and welcoming reputation.
- **Strengthening community engagement**
Expand outreach, events, and participation beyond Old Town.
- **Cultivating identity, destinations, and amenities**
Elevate Lewisville as a unique, family-friendly community.
- **Emphasizing quality of life, safety, and inclusion**
Residents prioritize belonging, safety, and equitable access.





Liveable Lewisville

Focus: Housing, complete communities, daily quality of life

- **Enhancing everyday amenities and retail**
Need for grocery stores, coffee shops, and local gathering places.
- **Emphasizing beauty, livability, and quality**
Revitalize aging developments to maintain modern, attractive neighborhoods.
- **Balancing growth and housing options***
Promote diverse housing types while maintaining access to jobs, goods and services.
- **Housing has become less affordable to the average resident**
Affordability cited as one of the city's top concerns.

*Overlaps with Growing Lewisville





Playful Lewisville

Focus: Arts, culture, recreation, parks and public spaces

- **Improve access to Lewisville Lake and water features**
Residents value recreation opportunities but face access barriers.
- **Expanding arts, culture, and recreation opportunities**
More neighborhood-based and small events and festivals.
- **Providing exciting places to meet, engage, and play**
Desire for more parks and “third spaces” for socializing and entertainment, particularly for teens and youth.





Innovative Lewisville

Focus: Education, technology, and future-readiness

- **Future-proofing through innovation and education**

Investments in STEM, green energy, smart infrastructure, and digital access.

- **Preparing for emerging technologies**

Plan for AI, automation, and 6G connectivity to remain competitive.

- **Supporting and encouraging young professionals**

Create jobs and housing that attract and retain early-career talent.

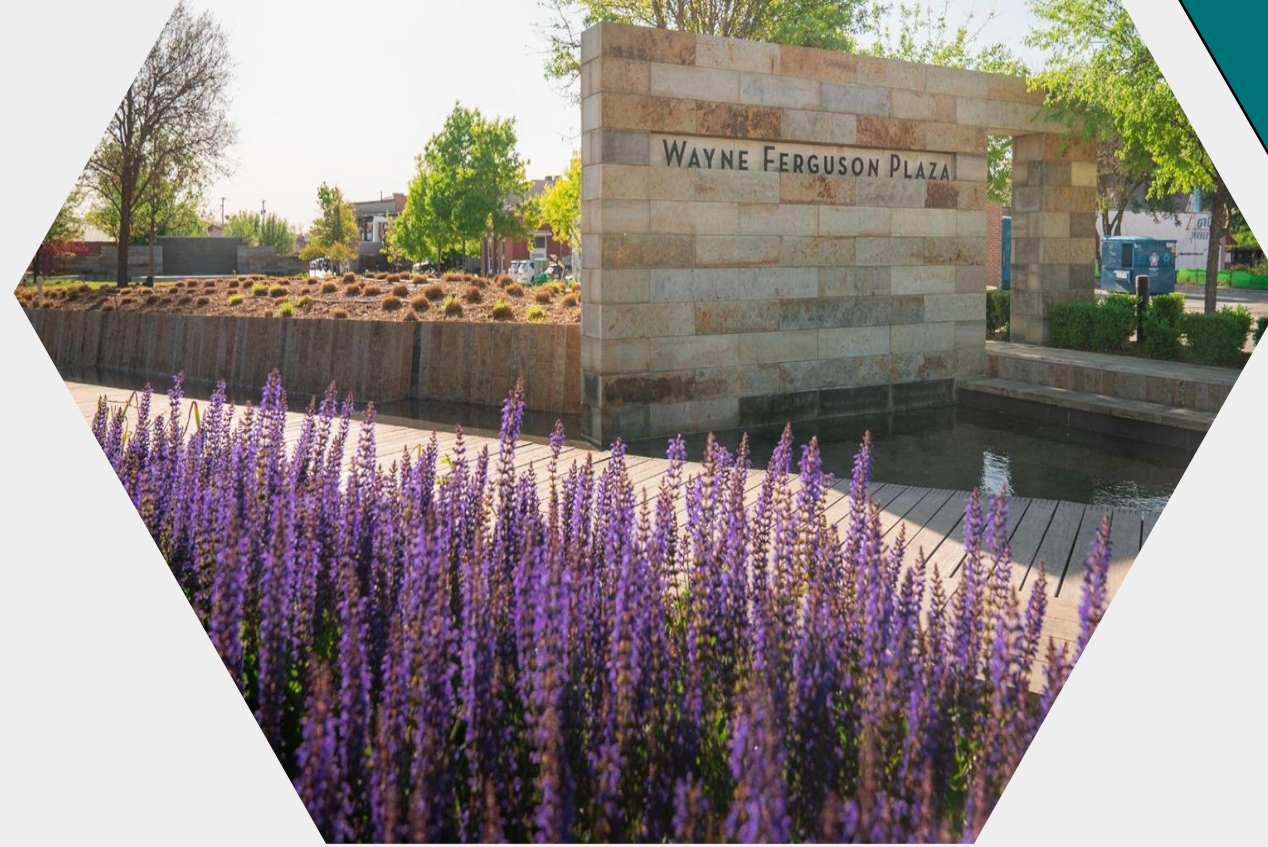
BIG IDEAS Phase

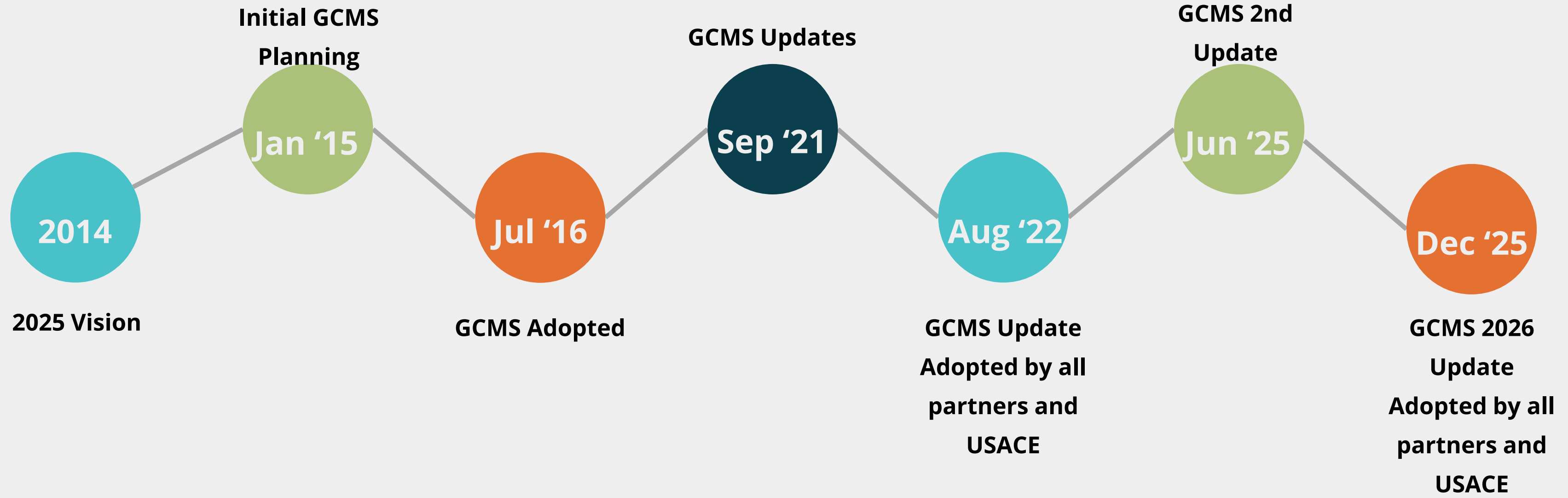

1 - USACE LLELA Lease Renewal

- **Description**

Renew USACE Lease of LLELA with three major partners (COL, LISD, UNT)

- **Status - Completed**

Completed — Lease finalized December 2023

- **Next Steps**

Maintain compliance and prepare for future periodic reviews



2 - Volunteer Management

- **Description**

Establish coordinated procedures related to volunteers contributing to the Green Centerpiece and related programs

- **Status - Ongoing**

Partners evaluating shared background check process; new volunteer platform launching for City of Lewisville

- **Next Steps**

Finalize shared standards and implement new system for all partners in 2026

3 - Green Centerpiece Programming

- **Description**

Collaborate to create hands-on/interactive programs that communicate a common environmental message

- **Status - Ongoing**

NOW program launched; vehicle acquired; LISD and COL community programming expanding

- **Next Steps**

Deploy NOW vehicle and grow neighborhood-based programs; shared programming of LISDOLA





4 - Collaboration & Partnerships

- **Description**

Foster ongoing collaborations between LLELA entities and create additional partnerships to support Green Centerpiece initiatives

- **Status - Ongoing**

Established agreements with KLB, LPA, EFCTMN, FOLLELA; UNT and COL expanded partnership

- **Next Steps**

Develop comprehensive marketing strategy document

8 - Prescribed Burn Management

- **Description**

USACE will review and approve the burn plans that are submitted by the University of North Texas to ensure proper management

- **Status - Ongoing**

COL PARD and LFD coordinates with partners for seasonal burns, planning, and best practices

- **Next Steps**

Continue conducting prescribed burns and post-burn assessments





10 - GC Marketing Plan

- **Description**
Market the Green Centerpiece to a wide market through various media channels with a focus on regional and local residents
- **Status - Ongoing**
Website updated (May 2023), Instagram launched (May 2024), no formal plan created yet
- **Next Steps**
Develop comprehensive marketing strategy document;
Working with UNT marketing students



11 - GC Activities and Events

- **Description**
Create a year-round calendar of activities that draw visitors to the Green Centerpiece
- **Status - Ongoing**
Recently added LLELA Open House, expanded night hikes, NOW outreach
- **Next Steps**
Expand accessibility and themed seasonal events



12 - Environmental Public Art

- **Description**

Public art in the Green Centerpiece, gateways and key locations throughout Lewisville to place focus on the Green Centerpiece

- **Status - Ongoing**

Integrated into Public Art Plan; LLELA murals; Purchase of "Hidden"

- **Next Steps**

Continue working with team to identify opportunities and incorporate into PARD Projects



13 - Residential Native Planting Certification Program

- **Description**

Develop a program that includes classes that teach plant identification and best practices for native plant residential landscaping

- **Status - Completed**

Completed – Roots For Wings launched in 2023; over 100 participants engaged

- **Next Steps**

Launch commercial expansion in 2026





14 - Participant Evaluations

- **Description**

Develop procedure for collecting participant feedback and outcomes to determine effectiveness and satisfaction with visits to LLELA and the Green Centerpiece

- **Status - Ongoing**

Surveys conducted and reviewed annually to guide programs and events

- **Next Steps**

Refine tools to assess long-term learning outcomes and growth of events and programs; identify gaps

15 - Healthy Infrastructure Plan

- **Description**

Create and execute the Healthy Infrastructure Plan to provide opportunities for enhancing Lewisville's open spaces, trails, and the urban tree canopy

- **Status - Completed**

Completed — Plan adopted in March 2023

- **Next Steps**

Implement priority projects and monitor results





16 - COL Sustainability Plan

- **Description**

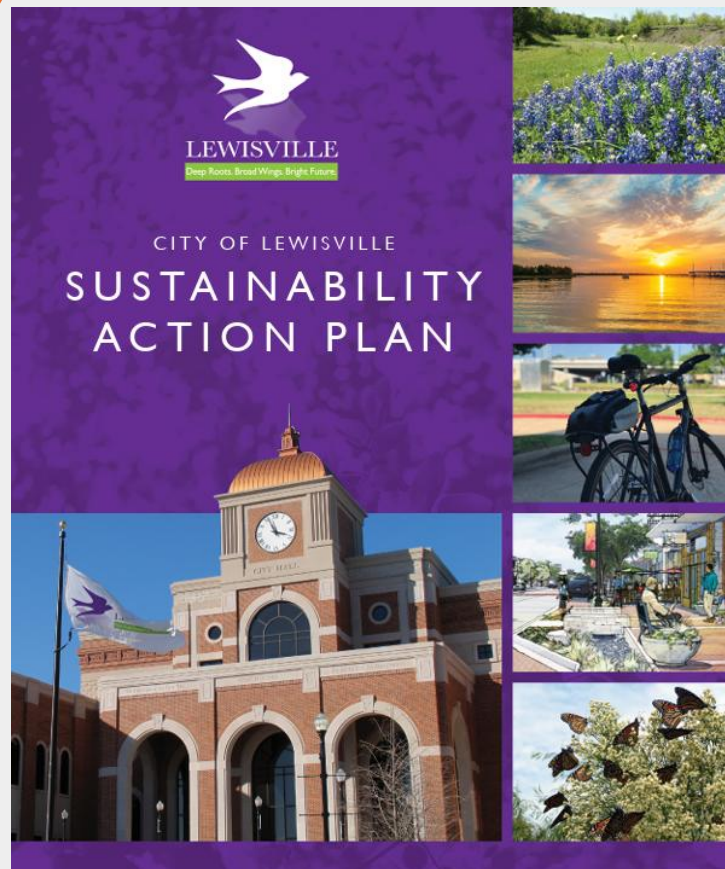
Establish guidelines for how the Green Centerpiece plans to achieve goals that create financial, societal, and environmental sustainability

Completed – Sustainability Action Plan adopted in 2021

- **Description**

Develop and implement Lake Park Master Plan

- **Status - Completed**

Completed — Plan approved Dec. 2024; new lease executed April 2025.

- **Next Steps**

Complete shoreline improvements near Boat Ramp #2; Phase 1 design and start construction of Day Use/Campground areas; work with Matthew Southwest and SunTex on Marina redevelopment

18 - LLELA Interpretive Plan

- **Description**

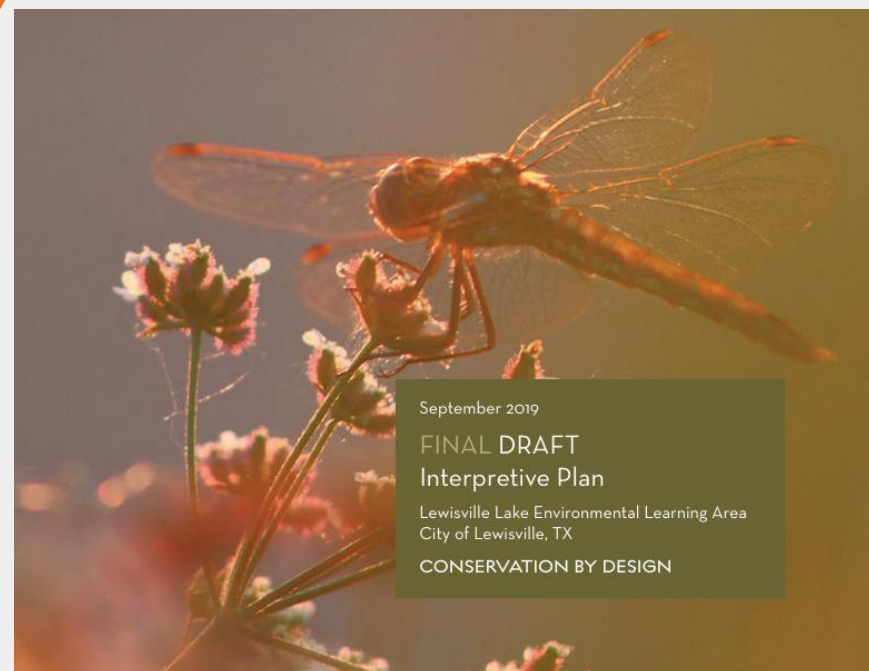
Address the opportunities, concerns, and issues described in the LLELA Interpretive Plan

- **Status - Ongoing**

Signage designed & installed, website updated, next phase targets Nature Center elements

- **Next Steps**

Nature Center design and construction; Enhanced programming





19 - Facilities Maintenance Program

- **Description**

Develop a plan and program for maintaining facilities within the Green Centerpiece including the cabin and ancillary buildings

- **Status - Ongoing**

SOPs in place; Log Home design work underway

- **Next Steps**

Complete Log Home design and start repairs; Incorporation of maintenance considerations to Nature Center design

20 - GC Maintenance Program

- **Description**

Establish a maintenance program for maintaining outdoor recreation areas, urban forests, greenbelts and trail systems in natural areas throughout the parks system

- **Status - Ongoing**

SOPs created (Trail Building/Maintenance, PPP, Urban Forestry, etc.); routine maintenance and metrics collection underway

- **Next Steps**

Evaluate SOP effectiveness and identify gaps



21 - Capital Investment

- **Description**

Plan, fund, improve, design, and construct infrastructure to enhance connection to and sustainable use of the Green Centerpiece

- **Status - Ongoing**

Kayak launch and Log Home design started; Urban Forester hired for management of tree canopy

- **Next Steps**

Finalize RFQ and select design firm for Nature Center; Project construction; Conduct full tree inventory





22 - Land Acquisition & Development

- **Description**

Purchase, design and develop property in and beyond the Green Centerpiece to preserve the area's ecosystems.

- **Status - Ongoing**

Duwe Properties and Bennett Nature Park; site visits conducted.

- **Next Steps**

Pursue land purchases within GC and engage adjacent owners to develop to desired standards; FY26 Action Step; Work with IES on assessing properties for forestry management



31 - FOLLELA Agreement

- **Description**
Create and adopt a formal partnership agreement with the Friends of LLELA that builds a flexible framework for the partners to share responsibilities
- **Status - Completed**
FOLLELA signed MOU with COL in 2024
- **Next Steps**
