A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION HELD IN THE CITY OF LEWISVILLE ON SATURDAY, MAY 2, 2026, TO ELECT CITY COUNCIL MEMBER PLACE NO. 1 AND CITY COUNCIL MEMBER PLACE NO. 3; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in accordance with Resolution No. 0818-26-RES approved on February 2, 2026, by the Lewisville City Council, the General Election was held in and throughout the City of Lewisville, Texas, on Saturday, May 2, 2026, to fill the terms of office for the Council Member – Place No. 1 and Council Member – Place No. 3, on the Lewisville City Council; and,

WHEREAS, the City Council met in regular session for which notice had been posted in all things as required by law, on Wednesday, May 13, 2026, and canvassed the election returns of the above-mentioned elections; and,

WHEREAS, it was found that each of the candidates in said General Election received the following votes:

WHEREAS, it is now necessary to declare the results of such General Election and the candidates that received the majority of the votes cast for the particular places listed;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:

SECTION 1. The General Election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law, and that Brent Kuykendall was duly elected Council Member Place No. 1, and that said aforementioned party is hereby declared duly elected to said respective office, subject to the taking of his oath as provided by the laws of the State of Texas.

SECTION 2. The General Election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law, and that Ronni Cade was duly elected Council Member Place No. 3, and that said aforementioned party is hereby declared duly elected to said respective office, subject to the taking of her oath as provided by the laws of the State of Texas.

SECTION 3. The City Council hereby finds and determines, as a result of this canvass, that a total of [redacted] persons voted in the General Election held on Saturday, May 2, 2026.
