

**BOUNDARY SURVEY**

Being a 0.313 acre tract of land situated in the J.W. King Survey, Abstract No. 696, in the City of Lewisville, Denton County, Texas, and being a part of Lot 5, Block F of the Original Town of Lewisville, according to the Plat thereof recorded in Volume 76, Page 160 of the Plat Records of Denton County, Texas, and being all of that certain tract of land conveyed to John K. DeLay and wife, Janice W. DeLay, as described by deed recorded in Volume 1217, Page 468 of the Real Property Records of Denton County, Texas (R.P.R.D.C.T.), and being more particularly described as follows:

**BEGINNING** at a 1/2 inch iron rod with a yellow cap marked "Arthur Surveying Company" set for the southwest corner of the herein described tract, same point being the southeast corner of a tract of land conveyed to Mark B. King, as described by deed recorded in Volume 5181, Page 4357, R.P.R.D.C.T., same point being in the north line of said West Walters Street, same point from which a 500 feet found at the southwest corner of said Block F bears South 89 degrees 56 minutes 12 seconds West, a distance of 473.68 feet;

**THENCE** North 00 degrees 08 minutes 13 seconds West, along the east line of said King tract, a distance of 150.00 feet to a 1/2 inch iron rod with a yellow cap marked "Arthur Surveying Company" set for corner in the south line of a tract of land conveyed to Grady Aaron and wife, Wannell Aaron, as described by deed recorded in Volume 710, Page 547 of the Deed Records of Denton County, Texas;


**THENCE** North 89 degrees 56 minutes 12 seconds East, along the south line of said Aaron tract, a distance of 91.06 feet to a 1/2 inch iron rod with a yellow cap marked "Arthur Surveying Company" set for corner in the west line of Charles Street (a 60 foot right-of-way);

**THENCE** South 00 degrees 00 minutes 00 seconds West, along the west line of said Charles Street, a distance of 150.00 feet to a 1/2 inch iron rod with a yellow cap marked "Arthur Surveying Company" set for corner at the intersection of the west line of said Charles Street and the north line of said West Walters Street, same point being the southeast corner of said Block F;

**THENCE** South 89 degrees 56 minutes 12 seconds West, along the north line of said West Walters Street, a distance of 90.70 feet to the **POINT OF BEGINNING** and containing a total of 0.313 acre of land, more or less, and being subject to any and all easements that may affect.

NOTE: BASIS OF BEARINGS IS THE EAST LINE OF SUBJECT TRACT.
