The City Council approved the zone change to Medical District on March 15, 2021, to allow the development of Sparrow Senior Living, a retirement community with 192 dwelling units, on this site. City staff has since worked with the applicant on the final plat for this development and established the required park fees. Because the purchase of this property from the Lewisville Independent School District (LISD) is in process, the developer is requesting a variance to delay the dedication of parkland (or cash in lieu of) and payment of the parkland development fee until the issuance of the first building permit, at which time all due amounts will be paid in full and the property will be dedicated by an amending plat.

The City staff's recommendation is that the City Council approve the variance as set forth on caption above.

Richard E. Luedke, AICP, Planning Director was available to address any questions posed by the City Council.

Mayor Pro Tem Green bought up discussion regarding the timing between the fees needing to be paid and the issue of the final plant needing to be done, she suggested that this was something that may need to be considered for a change so the City Council would not have to consider variances since this has come up before. Director of Planning and Zoning Richard Leudke advised staff would take a look that that.

The applicant proposes to demolish the current building and construct a new restaurant. Since this property is located within the IH 35E Overlay, the applicant requests the following nine Alternative Standards: a) an increased build to zone of 0 to 70 feet; b) a 40 foot build to maximum along IH 35E; c) a driveway without a deceleration lane along IH 35E; d) street tree spacing up to 50 feet and in an irregular manner along the Primary Pedestrian Street; e) trees to be located in existing landscape areas within the parking lot; f) three additional pedestrian scale lights as shown; g) a reduction in pedestrian amenities as follows: one trash receptacle, one bike rack, and one bench; h) a reduction to 25 percent for windows on the ground floor facades on primary Pedestrian Streets and adjacent to sidewalks contingent on additional plantings and wall treatments; and i) a reduction to 30 percent for awnings along the Primary Pedestrian Street. The Overlay District Board recommended unanimous approval (6 0) of the nine alternative standards on July 20, 2021.

The City staff's recommendation is that the City Council approve the nine Alternative Standards as presented.

Richard E. Luedke, AICP, Planning Director and Daniel Stewart, Development Engineering Consultants, applicant were both available to address any questions posed by the City Council.

Discussion was held that this property was chosen for the visibility and access to the site, and that the former occupant had been successful.

On February 17, 2021, Mayor Rudy Durham, acting in accordance with authority granted to him under the City Charter and Code of Ordinances and under section 418.108(a) of the Texas Government Code, declared a local state of disaster for public health emergency due to concerns related to COVID 19 (the "Disaster Declaration"), which the Lewisville City Council subsequently ratified, supported, and continued until 11:59 p.m. on August 16, 2021. Ongoing evaluation of circumstances related to the virus and the updated recommendations of the Centers for Disease Control and the Texas Department of State Health Services indicate that the conditions necessitating the Disaster Declaration have and will continue to exist for a period extending beyond August 16, 2021.

The City staff's recommendation is to approve the resolution as set forth in the caption.

- Director of Strategic Services Gina McGrath advised that the City has received the Government Finance Officers Association Distinguished Budget Award for the 29th consecutive year. She advised that this award recognizes how well the City adheres to best practices in budgeting and how well it conveys information to the public about the budget in four distinct areas: as a policy document, as a financial plan, as an operations guide, and as a communications device. In addition, the City received the Performance Measures Recognition Award for the first time. There were only two of these awards given out in Texas last year. The award recognizes the use of performance data in making operational and budgeting decisions. The City was commended on its use of the Performance Dashboard. The dashboard was created in 2017. It is an online, real-time performance management system used to show citywide live metrics and statistics. There are 149 different metrics on the site. Users can view performance metrics by department and by the Big Moves of the Lewisville 2025 vision plan. Ms. McGrath advised of the results of the recycling survey that was recently held.
- Director of Neighborhood Services advised of the Clear The Shelter dates coming up that would be occurring at the Gene Carey Animal Shelter. He advised of media coverage that would be conducted.



CRIMINAL STREET GANG DEFINED

A Criminal Street Gang means three or more persons having a common identifying sign or symbol, or an identifiable leadership, who continuously or regularly associate in the commission of criminal activities.

Documenting Gang Members

- All law enforcement agencies are <u>required</u> to have a gang database
- TXGang database is a repository provided by DPS for agencies to document gang members (565 use TXGANG)
- Adults are removed from database after 5 years, unless revalidated
- Juveniles are removed after 2 years, unless revalidated
- Database entry by AGENCY, not the RESIDENCY of the gang member. LPD numbers do not reflect number of gang members living in our city



City of Lewisville Homeless Update 2021

Estimates are approximate based on officers on the streets during contacts with the homeless on a daily basis.

Over 254 homeless contacted in last 5 years
 (Up from 202 in 2020) Expected
 This is a running total, NOT how many are currently in the city

- Some regulars, many transient or intermittent
- Approximately 150 have not been seen/contacted in over a year

(Up from 50 in 2020) Improvement



 We are down to approximately <u>10-25 homeless in</u> <u>Lewisville</u> at any time

(down from 100-150 in 2020) Improvement

 Approximately 90% of the homeless accept the Community Resource book

(up from 75% in 2020) Improvement



Approximately 50% actually follow-up with a referral

(up from 10% in 2020) Improvement

- Some resources limited/overbooked
- Waiting lists for long term
- Some don't meet the criteria for some assistance
- Many simply forget, mental illness, lose interest, don't follow-up
- Approximately 10% long-term homeless (down from 65% in 2020) <u>Improvement</u>
 - Refuse all help and express no desire for change
 - Much fewer make homeless their way of life now



 Approximately 80% admitted to, or believed, some form of mental illness

(about the same as 2020)
Not all have even been official diagnosed yet

- Approximately 95% history of drug/alcohol addiction (down from 99% in 2020)
 - Either can't or not willing to stop
 - Most have been involved/associated with local criminal activities:
 - Minor misdemeanors (including alcohol offenses)
 - Thefts
 - Some Felonies (including violence and drugs)



Some of the key elements needed for success:

- Drug or Alcohol Rehab/Counseling, MHMR Counseling (they can't keep a job if this is not addressed)
- Obtaining or renewing a Texas Identification Card or Texas Driver's License
- Job assistance
- Transportation assistance
- Housing or shelter
- Food/Clothing assistance

Resources are available to help the homeless in these areas



Homeless Contacts

COMPLETELY VOLUNTARY

- We build trust with the individual
- We try to learn more about the homeless person
- Get them involved, proactive
- Educate them on Resources Available



Homeless Contact Information Obtained

COMPLETELY VOLUNTARY

- Last contacted, locations, time since last contact, health status
- Sex Offender/Gang Member
- Homeless since/Total Homeless Time
- Homeless ended
- Initial causes of homelessness

Addressing Needs Continued

- What resources may be available to help
- Help customize a plan for their unique circumstances
- Review the Community Service Book and leave them the copy
- Provide referrals
- Provide a ride directly to a service/resource
- MHMR, Mayhill, UBH, Housing/shelter, Food, Clothing, Veteran's resource, Housing, Food, Clothing
- Over the phone counseling
- Computer and/or internet service
- Coordinate with their doctors/nurses or other medical staff
- Help get appointments and prescriptions filled
- Help obtain ID's, Driver's Licenses, SSN Cards
- Job Resources
- Veterans Resources



Common Barriers

- Alcohol/Drug dependency
- Mental Disability
- Broken or Dysfunctional Family or Home Life/Support
- Strictly Voluntarily
 May need help but many can and do refuse
 If not a danger to themselves/others, or criminal
 activity involvement

However, resources are available that a homeless person may need

- Plain clothes Mental Health Officers and Paramedics
- Unmarked units
- Dedicated Team for those in Crisis



CoCare Crisis Team Focus

- Follow up on suicide attempts
- Respond to calls involving homeless individuals
- Work with the homeless
- Provide homeless residents with resources to help them get the assistance
- Follow up on repeated calls involving the elderly
- Assist the elderly with needed resources
- Assist in arson investigations
- LPD officers will only assist as needed
