A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, AUTHORIZING VARIOUS AGREEMENTS. **INCLUDING** ANINTERLOCAL AGREEMENT, REGARDING THE DISBURSEMENT OF GRANT FUNDING WITH VARIOUS SUBRECIPIENTS **OF RECEIVING PORTIONS** THE **CITY** LEWISVILLE'S U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT COMMUNITY DEVELOPMENT **GRANT** BLOCK **ENTITLEMENT FUNDING** VARIOUS RECIPIENTS RECEIVING THE CITY OF LEWISVILLE'S SOCIAL SERVICE AGENCY FUNDING FOR FY 2025-2026; AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO EXECUTE SAID AGREEMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Lewisville received Community Development Block Grant (CDBG) entitlement funding from the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, on August 4, 2025, the Lewisville City Council approved the FY 2025-2026 CDBG Budget submitted by the Lewisville CDBG Advisory Committee which allocates CDBG entitlement funds to subrecipients; and

WHEREAS, the City Council finds that the CDBG Subrecipient Agreements attached hereto as Exhibits A - E meet the national objective of benefitting low- and moderate-income persons; and

WHEREAS, the City Council finds that the City-funded Agreements attached hereto as Exhibits F - P perform an important human service for the residents of Lewisville without regard to race, religion, color or national origin; and

WHEREAS, the City Council finds that the Interlocal Agreement attached hereto as Exhibit Q performs an important public purpose, the provision of mental health services, for the residents of Lewisville; and

WHEREAS, the City Council wishes to fund the CDBG Subrecipient Agreements, attached hereto as Exhibits A - E, in a total amount not to exceed \$127,140.90, the City-funded Agreements, attached hereto as Exhibits F - P, in a total amount not to exceed \$226,000.00, and the Interlocal Agreement, attached hereto as Exhibit Q, in a total amount not to exceed \$14,000.00, and to authorize the City Manager or her designee to execute the attached agreements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:

SECTION 1. The findings and recitations contained in the preamble of this resolution are incorporated herein by reference.

SECTION 2. The City Manager, or her designee, on behalf of the City of Lewisville, is authorized to execute the CDBG Subrecipient Agreements regarding the disbursement of CDBG entitlement grant funding attached hereto as Exhibits A - E, disbursing such funding in a total amount not to exceed \$127,140.90.

SECTION 3. The City Manager, or her designee, on behalf of the City of Lewisville, is authorized to execute the City-funded Agreements regarding the disbursement of City of

funding in a total amount not to exceed \$226,000.00.

social service agency grant funding attached hereto as Exhibit Q, disbursing such funding in a
