The City of Lewisville is being asked to cast its votes for the Denton Central Appraisal District Board of Directors. Lewisville is allocated 153 votes and may cast all of them for a single candidate or divide them among candidates as Council so determines. Since numerous ISDs control the larger blocks of votes, it is very difficult to predict where Lewisville's votes would best be used. However, it is generally more effective to cast the votes as a block rather than dividing them up among candidates. Dividing the votes can dilute the impact. Votes are due by December 15, 2024.

The City staff's recommendation was that the City Council consider the resolution as set forth in the caption above.

MOTION: Upon a motion made by Council Member Green and seconded by Council Member Jones, the Council voted six (6) "ayes" and no (0) "nays" to approve <u>Resolution</u> <u>No. 0716-24-RES</u>, casting the votes for the Denton Central Appraisal District Board of Directors as follows: 96 votes for Ann Pomykal, 50 votes for Alex Buck and 7 votes for Ray Martin. The motion carried.
