A RESOLUTION OF THE CITY COUNCIL OF THE CITY LEWISVILLE, TEXAS, **AUTHORIZING** PARTICIPATION WITH THE STATE OF TEXAS. THROUGH THE OFFICE OF THE ATTORNEY GENERAL, IN THE PURDUE PHARMA AND SACKLER FAMILY **SETTLEMENT AND APPROVING** SUBDIVISION PARTICIPATION AND RELEASE FORM REGARDING THE SAME; AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO EXECUTE ALL NECESSARY DOCUMENTS IN CONNECTION WITH THE ABOVE ON BEHALF OF THE CITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City obtained information indicating that Purdue Pharma, L.P., Purdue Pharma, Inc., and their past and present direct and indirect parents and subsidiaries and other associated entities, as well as the Sackler family and their associated entities ("Defendants") have engaged in fraudulent and/or reckless manufacturing, marketing, and distribution of opioids that has resulted in addictions and overdoses; and

WHEREAS, these actions, conduct and misconduct have resulted in significant financial costs to the City; and

WHEREAS, on November 15, 2021, the Lewisville City Council adopted and approved the Texas Opioid Abatement Fund Council and Settlement Allocation Term Sheet (the "Texas Term Sheet") approving the allocation of any and all opioid settlement funds within the State of Texas, attached hereto as Exhibit "A"; and

WHEREAS, the State of Texas, through the Office of the Attorney General, has entered into a settlement agreement with the Defendants, which includes Texas political subdivisions and which will provide funding and injunctive relief (the "Settlement Agreement"); and

WHEREAS, in order to participate in the Settlement Agreement, the City must approve the Subdivision Participation and Release Form associated with the Settlement Agreement, which requires the City to release certain claims against the Defendants as consideration for participation in the Settlement Agreement; and

WHEREAS, the City Council finds that it is in the best interest of the City of Lewisville to participate in the Settlement Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:

SECTION 1. There is a substantial need for repayment of opioid-related expenditures and payment to abate opioid-related harms in and about the City of Lewisville.

SECTION 2. The Lewisville City Council agrees to the terms outlined in and approves the Subdivision Participation and Release Form associated with the Settlement Agreement, and authorizes the City Manager, on behalf of the City of Lewisville, to execute all necessary documents in connection with the Settlement Agreement, including the Subdivision Participation and Release Form associated with the Settlement Agreement, attached hereto as **Exhibit B**.

SECTION 3. The City Council understands that the allocation of direct payment funds and other funds made available through the Settlement Agreement is set forth in the Texas Term Sheet, attached hereto as **Exhibit A**.

SECTION 4. This resolution shall take effect immediately upon adoption.
