Public Hearing: Consideration of an Ordinance of the Lewisville City Council, Amending the Zoning Ordinance by Rezoning Approximately 3.027-Acres of Land, out of the Edmond Aday Survey, Abstract Number 11; Located at 421 Bennett Lane; From Agriculture-Open Space (AO) District Zoning to Light Industrial (LI) District Zoning; Correcting the Official Zoning Map; Preserving all Other Portions of the Zoning Ordinance; Determining That the Zoning Amendment Herein Made Promotes the Health, Safety, and General Welfare of the City; Providing for a Savings Clause, Repealer, Severability, a Penalty, and an Effective Date, as Requested by James Yu, Lovett Industrial LLC, on Behalf of Eduardo and Ana Ortuno, the Property Owners. #### **ADMINISTRATIVE COMMENTS:**

421 Bennett Lane is currently zoned Agriculture Open Space and is requested to be rezoned to Light Industrial, matching the zoning to north, east, and south of the property. The Planning & Zoning Commission unanimously (7-0) recommended approval of this case at their July 15, 2025, meeting.

Public Hearing: Consideration of an Ordinance of the Lewisville City Council, Amending the Zoning Ordinance by Granting a Special Use Permit for Automobile Repair (Minor) on Approximately 0.61 Acres Legally Described as Thomas Addition, Lot 1, Block A, Located at 500 South Kealy Avenue, and Zoned Light Industrial (LI) District; Providing for a Savings Clause, Repealer, Severability, Penalty, and an Effective Date; as Requested by Ezekiel Kaufman, Mobile Tire, LLC, the Property Owner (Case No. 25-06-9-SUP).

## **ADMINISTRATIVE COMMENTS:**

Mobile Tire is a minor automotive service shop looking to occupy the existing building at 500 South Kealy Avenue. A Special Use Permit is required as the property does not meet the 200 foot distance from a single-family property, has bay doors facing the street and does not have a landscape buffer. The proposed

business only operates on vehicles off-site of their establishment and will not store any customer cars on the premises. The Planning & Zoning Commission unanimously (7-0) recommended approval at their July 15, 2025, meeting.

#### **ADMINISTRATIVE COMMENTS:**

The 2023-2024 Community Development Block Grant (CDBG) Annual Action Plan (AAP) included allocating \$345,799 to a Multifamily Accessibility Program (MAP) to modify residential units for low-to-moderate income renters in multifamily housing complexes to gain or increase accessibility to the units or common area. City staff encountered challenges identifying a multifamily complex willing to utilize these CDBG funds. Reallocating the funds to other projects will ensure timely expenditure and compliance with the Department of Housing and Urban Development's (HUD) timeliness test. Funding would be reallocated to three projects: Fox Hembry Historical Cemetery Restoration, United Way of Denton County HVAC Unit Replacement, and Boys and Girls Clubs of Greater Tarrant County HVAC Replacement Projects.

# **ADMINISTRATIVE COMMENTS:**

The 2024-2025 Community Development Block Grant (CDBG) Annual Action Plan (AAP) included allocating \$166,166 to a Multifamily Accessibility Program (MAP) to modify residential units for low-to-moderate income renters in multifamily housing complexes to gain or increase accessibility to the units or common area. City staff encountered challenges identifying a multifamily complex willing to utilize these CDBG funds. Reallocating the funds to other projects will ensure timely expenditure and compliance with the Department of Housing and Urban Development's (HUD) timeliness test. Funding would be reallocated to two projects: Boys and Girls Clubs of Greater Tarrant County HVAC Replacement and Denton County Friends of the Family's Family Justice Center.

#### **RECOMMENDATION:**

That the City Council approve the resolution and authorize the City Manager, or her designee, to submit the amendment to the U.S. Department of Housing and Urban Development as set forth in the caption above.

Public Hearing: Consideration of a Resolution of the City Council of the City of Lewisville, Texas, Providing for the Adoption of the 2025 Annual Action Plan as Required by the U.S. Department Of Housing And Urban Development And Authorization for the City Manager, or Her Designee, to Submit the Plan to the U.S. Department of Housing and Urban Development.

#### **ADMINISTRATIVE COMMENTS:**

An Annual Action Plan must be submitted to the Department of Housing and Urban Development (HUD) by August 15, 2025 as a requirement to receive Community Development Block Grant (CDBG) funds of \$847,606 and HOME Investment Partnership Funds (HOME) of \$347,555.08 in FY 2025-2026. The

CDBG Advisory Committee reviewed applications submitted by non-profit agencies for projects that address HUD national objectives and Consolidated Plan priorities. At a meeting on June 17, 2025, the Committee voted 5-0 to recommend a social services budget. The Plan was made available for a 30 day public comment period.

#### **RECOMMENDATION:**

That the City Council approve the resolution and authorize the City Manager, or her designee, to submit the plan to the U.S. Department of Housing and Urban Development as set forth in the caption above.

# F. Visitors Forum

- 7. Approval of a Bid Award for an Annual Requirements Agreement for Underground Utility Repairs to Four Star Excavating, Dallas, Texas, in the Estimated Amount of \$944,960; and Authorization for the City Manager, or Her Designee, to Execute the Agreement.

#### **ADMINISTRATIVE COMMENTS:**

This Annual agreement consists of utility item repairs, including underground pipelines, water services, valves, sewer services, fire hydrants, storm drainage

pipe. This agreement is intended to be used for both scheduled and emergency work. The quantity of each type of repair is estimated on an annual basis and is not indicative of the actual quantity of work. Quantities may vary each year based on City staffing levels and the needs of the Utility. A total of forty-seven (47) bid invitations were downloaded from Bonfire. Four (4) bids were received and opened on May 29, 2025. An evaluation of all bids was performed, and Four Star Excavating is recommended for award as the lowest, responsible bidder. Funding for this project is available in the capital project titled Miscellaneous Water and Sewer Line Repair.

#### **RECOMMENDATION:**

That the City Council approve the award and authorize the City Manager, or her designee, to execute the agreement as set forth in the caption above.

8. Approval of Amendment No. 3 to the Professional Services Agreement with OCMI, Inc., Richardson, TX, Reducing the Agreement Amount by \$555,211 for the Prairie Creek Wastewater Treatment Plant II (PCWWTP) Aeration Basin Expansion Project, Removing Construction Phase Services but Increasing Pre-construction Support; and Authorization for the City Manager, or Her Designee, to Execute the Agreement.

#### **ADMINISTRATIVE COMMENTS:**

The Prairie Creek Wastewater Treatment Plant, built in the 1950s, requires expansion as current flows approach 90% of its permitted capacity, triggering requirements for increased treatment and nutrient removal. completed the master plan in 2020, and OCMI, Inc. was engaged for project controls under a Construction Manager at Risk (CMAR) delivery method. Services with OCMI, originally Professional Agreement \$908,062, undergone three amendments. Amendment #1 corrected a fee miscalculation, the contract to \$802,188. Amendment #2 reallocated additional pre-construction services to transition from CMAR to Competitive Sealed Proposal (CSP) delivery, with no change in the total Amendment #3 will revise the scope to remove construction-phase services, extend pre-construction support, and further reduce the contract by \$555,211, bringing the new not-to-exceed amount to \$246,977. Funding is available in the WWTP Capacity Improvements Capital Project.

#### **RECOMMENDATION:**

That the City Council approve Amendment No. 3 and authorize the City Manager, or her designee, to execute the agreement as set forth in the caption above.

9. <u>Approval of Renewal of a New Five-Year Agreement with Hilltop Securities Asset Management, LLC for Arbitrage Rebate Compliance Service; and Authorization for the City Manager, or Her Designee, to Execute the Agreement.</u>

#### **ADMINISTRATIVE COMMENTS:**

Hilltop Securities has been engaged by the City to perform arbitrage rebate services related to municipal bond issuances since 1991. The most recent Arbitrage Rebate Compliance Service Agreement was for a five-year period ending FY2025. Arbitrage liability and rebate computation is a highly specialized and complex procedure and requires a thorough understanding and continued monitoring of changes of the Internal Revenue Service Tax Code as it relates to arbitrage. The proposed agreement includes an increase in the base fee from the previous five-year contract. The base fee for each debt obligation will increase from \$1,400 to \$1,600. The fee is only applicable when a computation is performed. A 10% discount is available when all required documentation is submitted in electronic format. For services involving the preparation of an IRS refund request, a flat fee of \$3,000 will apply when additional work is necessary.

#### **RECOMMENDATION:**

That the City Council approve the arbitrage rebate compliance service agreement as set forth in the caption above.

10. Approval of Subdivision Improvement Agreement for Park Improvements Between the City of Lewisville and Josey Lane LLC, and Authorization for the City Manager, or Her Designee to Execute the Agreement.

The proposed agreement creates a framework for the Developer to construct a small park according to city guidelines and dedicate parkland in a new residential development east of Josey Lane. The agreement will also provide the

#### **ADMINISTRATIVE COMMENTS:**

This Agreement replaces in its entirety the Interlocal Agreement between the Parties dated September 21, 2009 ("2009 Agreement") which allowed the two cities to share in the cost of running a Teen Court Program. This new Agreement will establish the Lewisville/Flower Mound Youth Services Program, which will consist of (a) teen court services pursuant to Article 45A of the Texas Code of Criminal Procedure and Chapter 54 of the Texas Family Code ("Teen Court"); and (b) youth diversion services pursuant to Article 45 of the Texas Code of Criminal Procedure.

## **RECOMMENDATION:**

That the City Council approve the interlocal agreement and authorize the City Manager, or her designee, to execute the agreement as set forth in the caption above.

12. Approval of a Resolution for the Acceptance of the 2025 State and Local Cybersecurity Grant Award in the Amount of \$39,201.74.

#### **ADMINISTRATIVE COMMENTS:**

The Information Technology Services Department received notice from the State of Texas Office of the Governor's Homeland Security Grants Division

that the City of Lewisville has been awarded a grant in the amount \$39,201.74 under the State and Local Cybersecurity Grant Program. The intent of the SLCGP grant program is to support state and local government efforts in reducing and managing systemic cyber risk. The funding will be used to implement a new network access control solution to improve overall security and access to the city's network. The original proposal and resolution submitted for approval inadvertently omitted the designation of the authorized official, which is a required component of the grant process. As a result, this item is being resubmitted for approval with the necessary designation included.
