**AN ORDINANCE OF THE LEWISVILLE CITY COUNCIL AMENDING THE FEE SCHEDULE OF THE CITY OF LEWISVILLE BY AMENDING FEES RELATED TO COMMUNITY RELATIONS AND TOURISM, ENGINEERING, FINANCE, FIRE, LIBRARY, NEIGHBORHOOD AND INSPECTION SERVICES, PARKS AND RECREATION, PLANNING AND DEVELOPMENT, AND PUBLIC SERVICES; AND AUTHORIZING EXISTING FEES AS PRESENTED; PROVIDING FOR A REPEALER, SEVERABILITY, AND AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City Council of the City of Lewisville, Texas, has determined that for the health, welfare, and safety of its citizens, certain amendments to the Fee Schedule of the City of Lewisville, as incorporated by reference into Section 2-201 of the Code of Ordinances of the City of Lewisville, Texas, are necessary;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:**

**SECTION 1.** The City of Lewisville Fee Schedule is hereby amended by updating fees related to Community Relations and Tourism, Engineering, Finance, Fire, Library, Neighborhood and Inspection Services, Park and Recreation, Planning and Development, and Public Services (as stated in Attachment A).

**SECTION 2.** The City Manager, or her designee, is hereby directed to update the Fee Schedule of the City of Lewisville, Texas, to reflect this amendment.

**SECTION 3.** All fees (as presented in Attachment B), both existing and proposed, are hereby authorized.

**SECTION 4. REPEALER.** Every ordinance or parts of ordinances found to be in conflict herewith are hereby repealed.

**SECTION 5. SEVERABILITY.** If any section, sentence, clause, or phrase of this ordinance shall for any reason be held to be invalid, such decision shall not affect the validity of the remaining sections, sentences, clauses, or phrases of this ordinance, but they shall remain in effect.

**SECTION 6. EFFECTIVE DATE.** This ordinance shall become effective on October 01, 2023, after passage and publication as required by law.

**SECTION 7. EMERGENCY.** It being for the public welfare that this ordinance be passed creates an emergency and public necessity, and the rule requiring this ordinance be read on three separate occasions be, and the same is hereby waived, and this ordinance shall be in full force and effect from and after its passage and approval.
