**SUBJECT:** Public Hearing: Consideration of an Ordinance of the City Council Amending the

Fee Schedule of the City of Lewisville by Amending Fees Related to Community Engagement, Engineering, Finance, Fire, Library, Municipal Court, Neighborhood and Inspection Services, Parks and Recreation, and Planning; and Authorizing Existing Fees as Presented in the Attached Fee Schedule ("Attachment B").

#### **BACKGROUND**

A public hearing to consider the proposed FY 2025-26 fee schedule is being held to allow the opportunity for public comment and to satisfy the requirements of Local Government Code Section 214.908.

As part of the annual budget process, changes to the fee schedule based on an analysis of current charges as compared to cost recovery goals and/or comparison to surrounding entities is conducted. In addition, fees are reviewed to make sure they are still applicable. Resulting modifications are proposed by the departments.

Historically, fee schedule information was codified and included in the Code of Ordinances. However, in 2020, City Council approved a non-codified fee schedule and left in place language stating that "a repository of fee schedule information is available on the City's website" in section 2.201 of the Code of Ordinances. Actual fee schedule information is now located on the City's website within the Finance section. This repository is maintained by the City Manager's Office.

#### **ANALYSIS**

Local Government Code Section 214.908 was amended in 2023 to require the building permit fee of a municipality to be abolished on the 10th anniversary after the date the fee is adopted or most recently authorized, unless the municipality's governing body holds a public hearing on the fee's reauthorization and reauthorizes the fee. Rather than holding a public hearing once every 10 years on the reauthorization of these specific fees, staff recommends a public hearing be held annually on the entire proposed fee schedule.

Proposed updates in this year's fee schedule include changes to Community Engagement, Engineering, Finance, Fire, Library, Municipal Court, Neighborhood and Inspection Services, Parks and Recreation, and Planning.

#### **COMMUNITY ENGAGEMENT**

#### **BILL WEAVER ARENA**

The City of Lewisville has introduced new fees for Bill Weaver Arena to support improved operations, cover equipment and utility use, and ensure public safety during events. These fees apply to rentals that include arena access, setup materials, utilities, and shared spaces. Additional charges may apply for City support services.

The updates reflect growing use of the facility and help fund future improvements such as permanent power, storage, and seating enhancements.

### **FINANCE**

The City of Lewisville recently completed an update to its utility rate study, and the rates shown here reflect the findings of that analysis.

Water and sewer rates for Legacy Lewisville and Castle Hills are listed separately here to show how the two areas are being brought into alignment. On the official fee schedule, however, these rates are combined into a single, unified structure that treats all customers equitably.

The unified structure provides a modest monthly decrease of \$8.92 for Castle Hills customers and a \$6.58 increase for Legacy Lewisville customers. This approach helps ensure reliable cost

recovery, supports future infrastructure investment, maintains strong financial health, and introduces conservation-based rates citywide.

The overall utility rate adjustment is projected at 7.4%, generating approximately \$3.67 million annually to invest in essential utility system improvements. Future rate adjustments will apply consistently to all customers across the city.
