AMENDMENT NO. 5 TO PROFESSIONAL SERVICES AGREEMENT for CORPORATE DRIVE – SEGMENTS 2, 3 & 4 FROM RAILROAD ST. TO HOLFORD'S PRAIRIE RD.

The Professional Services Agreement for Corporate Drive – Segments 2, 3 & 4 from Railroad St. to Holford's Prairie Rd. entered into by and between the City of Lewisville, Texas, a Texas home rule municipality (the "City"), and Halff Associates, Inc., a civil engineering firm, with principal offices located in Fort Worth, Texas (the "Consultant") (collectively, the "Parties") on September 19, 2017, as later amended, is hereby amended to include additional professional services and additional compensation in connection with the project at Corporate Drive – Segments 2, 3 & 4 from Railroad Street to Holford's Prairie Road ("Project").

WHEREAS, the City and Consultant entered into an Professional Services Agreement dated September 19, 2017 and subsequent amendments thereto dated October 24, 2018, November 1, 2018, September 13, 2021 and May 1, 2023 (the "PSA") such that the Consultant is to provide the services outlined therein; and

WHEREAS, if there is a change in scope or focus of the activities in the contract, or if it is necessary for the Consultant to do additional work such that there is a significant additional cost or expense to the City, it is necessary for the City to approve such work and/or for the Parties to change the PSA; and

WHEREAS, due to the complexity of constructing a bridge across a river and floodplain a third party construction administration and inspection services were needed to assist staff, the Parties recognize that it is necessary to modify the scope of work under the PSA by adding such work as is set out in the attached Exhibit "A," which is attached hereto and incorporated herein as if set out in full herein, including, but not limited to, review and management of all bridge and structural related submittals, RFIs, schedules and invoices; inspection of the bridge and associated retaining walls and appurtenances, comprising a substantial increase in the scope and complexity of Consultant's services; and

WHEREAS, the Parties recognize that the significant expansion of the scope of services being provided under the PSA also necessitates an increase in the total fee paid to the Consultant

NOW, THEREFORE, for and in consideration of the mutual acts and covenants set out herein, the Parties agree as follows:

- 1. Exhibit "A" outlines certain amendments to the scope of the PSA as such scope is outlined in the Attachment "B" to the PSA. Consultant, in addition to the work to be performed as outlined in the PSA, shall perform the task(s) described in the attached Exhibit "A" (the "Additional Services"). This amendment shall amend the Attachment "B" to the PSA to include the Additional Services.
- 2. The amount to be paid to Consultant under the PSA shall be increased by the sum of \$684,896.00, to reflect the Additional Services described in Exhibit "A." The total fee for the PSA will increase from \$2,223,631.00 to \$2,908,527.00.
- 3. This shall constitute an amendment to the PSA. All of the terms and conditions of the PSA shall remain in full force and effect, as amended hereto, unless set out otherwise herein.

By signature below, the Parties hereby bind themselves to the terms stated herein, including all attachments referred to herein.
