#### BACKGROUND

- Lewisville has been receiving CDBG funds from HUD since 1997
  - o FY25-26 \$847,606
- Only second year to receive HOME funds
  - o FY25-26 \$376,555.08
- Annual Action Plan
  - Must submit to show how CDBG and HOME funds will be allocated
  - Due to HUD on August 15
  - Required to have a 30 day public comment period
  - Can be amended if needed
- Timeliness Test
  - spending funds in a timely manner
  - o conducted 60 days before the end of the Program Year
  - no greater than one and one-half (1.5) times its annual grant remaining in the Line of Credit

- Staff discussed with Economic Development to add program funds to the Affordable Housing Notice of Funding Availability released in 2025
- Received no applications from multifamily complexes or developers, leading to an amendment of two Annual Action Plans to reallocate funding to other projects
