AN ORDINANCE OF THE LEWISVILLE CITY COUNCIL AMENDING THE LEWISVILLE CITY CODE CHAPTER 15, SECTION 15-36, BY ESTABLISHING A SCHOOL SPEED ZONE ON JOSEY LANE FROM 500 FEET NORTH OF THE MEMORIAL **ELEMENTARY** SCHOOL **NORTH** DRIVEWAY TO 500 FEET SOUTH OF LAKE FALLS **FOR** TERRACE: **PROVIDING** A REPEALER, SEVERABILITY, PENALTY, AND AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Lewisville, Texas, has determined that for the health, welfare, and safety of its citizens, amending Chapter 15, Section 15-36 of the Lewisville City Code is necessary.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEWISVILLE, TEXAS, THAT:

SECTION 1. Chapter 15, Section 15-36 of the Lewisville City Code is hereby amended by deleting the following language:

"Except as otherwise provided in this section, the city council has determined that, on days when school is in session, the prima facie reasonable and prudent maximum speed of the school zones designated below shall be a speed of 20 miles per hour, except that the prima facie reasonable and prudent maximum speed for the school zones located on Farm to Market Road 544 and Round Grove Road shall be 35 miles per hour."

And, in its place, inserting the following language:

"Except as otherwise provided in this section, the city council has determined that, on days when school is in session, the prima facie reasonable and prudent maximum speed of the school zones designated below shall be a speed of 20 miles per hour, except that the prima facie reasonable and prudent maximum speed for the school zones located on Farm to Market Road 544, Round Grove Road, and Josey Lane shall be 35 miles per hour."

SECTION 2. Chapter 15, Section 15-36 of the Lewisville City Code is hereby amended by adding the following street entry:

Street/ Highway	Designated School Zone
Josey Lane	From 500 feet north of Memorial Elementary School north driveway to 500 feet south of Lake Falls Terrace

SECTION 3. REPEALER. Every ordinance or parts of ordinances found to be in conflict herewith are hereby repealed.

SECTION 4. SEVERABILITY. If any section, sentence, clause, or phrase of this ordinance shall for any reason be held to be invalid, such decision shall not affect the validity of the remaining sections, sentences, clauses, or phrases of this ordinance, but they shall remain in effect.

SECTION 5. PENALTY. Any person, firm or corporation who violates any provisions of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof in the Municipal Court of Lewisville, Texas, shall be subject to a fine of not more than five hundred (\$500.00) dollars for each offense.

SECTION 6. EFFECTIVE DATE. This ordinance shall become effective immediately upon its passage and publication as required by law.

SECTION 7. EMERGENCY. It being for the public welfare that this ordinance be passed creates an emergency and public necessity, and the rule requiring this ordinance be read on three separate occasions be, and the same is hereby waived, and this ordinance shall be in full
