- Working closely with employers and payer agents to return a person to light or restricted duty, thus avoiding time-off from work.

- Minor/Urgent care and substance abuse testing available **24** hours a day **7** days a week through our after-hours program.

Injury Management:

Acute Injury / Illness Care:

- Accurate assessment of injury / illness
- Educate patient on injury prevention to reduce further risk
- Reassurance that primary interest is in the patient being returned to a professional and personal lifestyle as soon as medically appropriate
- Objective analysis to ensure job restrictions (light duty) that do not hinder the recovery process or increase the possibility of further injury

Physical Therapy:

- Early intervention of therapy to return a person to full-productive capabilities faster
- Aggressive and hands-on treatment tailored to meet the individual’s particular needs
- Instruction on proper mechanics to prevent further injury and education of incorporating these into the patient’s everyday lifestyle

IH2S - Integrated Health Strategies & Solutions specializes in the delivery of onsite annual/periodic OSHA mandated testing and medical surveillance. *IH2S* utilizes Mobile Medical Units (MMU's) which travel around the US in order to bring our services to the client's front door. When our highly trained staff presents to your different locations, *IH2S* will concentrate solely on you and your employees, and we will do all of this for approximately the same cost as dealing with your local clinic

- Trends of possible exposure
- Recommendations for IH monitoring / or investigations
- Any work-related claims or OSHA recordable issues
- Any threshold shifts
- Any additoanl recommended testing

- For all after-hours services please call **214-395-8817** (back-up numbers: 214-336-7166 or 214-334-4538)
- Please allow up to 45 minutes for our physician and staff to arrive at Occumed
- Upon arrival your employee will be offered the same level of care that your day shift employees receive at Occumed.
- For any necessary follow-up appointments the employee will be scheduled to see Dr. Inzer during normal business hours (M-F, 8am to 5pm).
- Please have the supervisor fill out the Occumed Authorization form and present it to the Occumed staff member upon arrival.
- For post-accident, (non-injury) substance abuse testing, an Occumed staff member will come to your facility and perform the testing on-site.
