This is to certify that I have, this date, made an on the ground survey of the property located at 1298 W. Main Street in the City of LEWISVILLE, Texas described as follows:

Being a 0.561 acre tract of land out of the J. W. Craft Survey, Abstract No. 295, City of Lewisville, Denton County, Texas and a portion of Lot 1, Block A, Mobil Oil Addition No. 1, an addition to the City of Lewisville, Denton County, Texas, according to Plat thereof recorded in Cabinet J, Page 302, Plat Records, Denton County, Texas and being more particularly described as follows;

BEGINNING at a Tx. Dot Monument found for corner, said point being the northeast corner of said 0.561 acre tract of land being described, same point being in the west line of Lot 5, Block E, Old Orchard Village East, an addition to the City of Lewilsville, according to the plat thereof recorded in Volume E, Page 20, Plat Records, Denton County, Texas, said point being the southeast corner of that certain tract of land conveyed to the City of Lewisville by Condemnation Clause as recorded in Volume 2890, Page 576, Deed Records, Denton County, Texas, said point also being in the south right-of-way line of West Main Street (F.M. Road No. 1171) (a 110.0 foot width right-of-way);

THENCE South 00 degrees 00 minutes 37 seconds East, departing the south right-of-way line of said West Main Street (F.M. Road No. 1171) and along the common line of said Lot 1, Block A, Mobil Oil Addition No. 1 and said Lot 5, Block A, Old Orchard Village East, a distance of 158.52 feet to an "X' cut set in concrete for corner, said point being the most easterly southeast corner of Lot 1, Block A, Mobil Oil Addition No. 1, same point being an angle point of said Lot 5, Block A, Old Orchard Village East, said point also being the most easterly southeast corner of said 0.516 acre tract of land being described;

THENCE South 44 degrees 59 minutes 23 seconds West, continuing along the common line of said Lot 1, Block A, Mobil Oil Addition No. 1 and said Lot 5, Block A, Old Orchard Village East, a distance of 21.21 feet to a 1/2 inch iron rod set with cap stamped "RPLS No. 1740" for corner, said point being the most southerly southeast corner of said Lot 1, Block A, Mobil Oil Addition No. 1, same point being an angle point of said Lot 5, Block A, Old Orchard Village East, said point also being the most southerly southeast corner of said 0.516 acre tract of land being described;

THENCE South 89 degrees 59 minutes 23 seconds West, continuing along the common line of said Lot 1, Block A, Mobil Oil Addition No. 1 and said Lot 5, Block A, Old Orchard Village East, a distance of 132.00 feet to a 1/2 inch iron rod set with cap stamped "RPLS No. 1740" for corner, said point being the southwest corner of said 0.516 acre tract of land being described, same point being the southeast corner of that certain tract of land conveyed to City of Lewisville by deed as recorded in Instrument No. 2010-34984, Official Public Records, Denton County, Texas, said point also being in the east right-of-way line of Old Orchard Lane (a variable width right-of-way);

THENCE North 04 degrees 29 minutes 21 seconds East, along the east right-of-way line of said Old Orchard Lane, a distance of 89.23 feet to a 1/2 inch iron rod set with cap stamped "RPLS No. 1740" for corner, said point being an angle point of said City of Lewisville tract, same point being an angle point of said 0.516 acre tract of land being described;

THENCE North 00 degrees 00 minutes 37 seconds West, continuing along the east right-of-way line of said Old Orchard Lane, a distance of 72.00 feet to a 1/2 inch iron rod set with cap stamped "RPLS No. 1740" for corner, said point being the northeast corner of said City of Lewisville tract, same point being the most westerly northwest corner of said 0.516 acre tract of land being described, said point also being at the intersection of the east right-of-way line of said Old Orchard Lane and the south right-of-way line of said West Main Street (F.M. Road No. 1171);

THENCE North 45 degrees 05 minutes 23 seconds East, along said aforementioned intersection, a distance of 18.37 feet to a 1/2 inch iron rod set with cap stamped "RPLS No. 1740" for corner, said point being the most northerly northwest corner of said 0.516 acre tract of land being described, same point also being the southwest corner of said City of Lewisville tract;

THENCE South 89 degrees 49 minutes 37 seconds East, along the south right-of-way line of said West Main Street (F.M. Road No. 1171), a distance of 126.99 feet to the POINT of BEGINNING and containing 24,437 square feet or 0.561 acres of computed land
