2018 Action Plan Summary

Lewisville will receive \$699,808 in CDBG funding and will add an estimated \$170,000 in City Social Service Agency funding for a total Grants Budget of \$869,808.

CDBG social services funding: Children's Advocacy Center \$20,000, Chin Community Ministry \$8,000, Christian Community Action \$10,000, Court Appointed Special Advocates \$14,000, Denton County Friends of the Family \$10,000, PediPlace \$18,971, SPAN \$24,000.

City Social Service Funding: Boys & Girls Club \$5,000, Camp Summit \$5,000, Communities in Schools \$30,721, Friends of the Family \$6,750, Denton County MHMR \$8,000, Giving Hope \$8,000, Health Services of North Texas \$20,000, Journey to Dream \$10,000, New Hope Learning Center \$10,000, PediPlace \$39,029, Retired Senior Volunteer Program \$10,500, Special Abilities of North Texas \$5,000, Youth and Family Counseling \$12,000. Considered but not funded: Teena's Place.

Housing and Community Development Projects: Children's Advocacy Center - \$60,000 for an Outdoor Play Therapy Area; Habitat for Humanity - \$40,000 for Land Acquisition in support of affordable housing; Salvation Army - \$354,876 for design of a Lewisville Community Center. Administration: \$139,961.

Prior Year Amendment:

The 2015 Alvin Turner Sr. Park project is amended to revise the scope of work to include playground and exercise equipment in place of restrooms.
