THENCE South 00 deg. 04 min. 59 sec. East, along the common line of said Lot 7B and said Lot 3, passing at a distance of 199.36 feet a 5/8 inch iron rod found for the southwest corner of said Lot 3, same being the most northerly northwest corner of Lot 1R, Block A, said SEC Garden Ridge & 1171 Addition (Cabinet L, Page 216), and continuing along the common line of said Lot 7B and said Lot 1R, a total distance of 300.00 feet to a 1/2 inch iron rod with yellow cap found (bears South 21 deg. 18 min. West, 0.29 feet) for the southeast corner of said Lot 7B;

THENCE continuing along the common line of said Lots 7B and 1R as follows: South 89 deg. 51 min. 00 sec. West (Plat drawing South 89 deg. 51 min. 00 sec. West)(Plat legal South 89 deg. 47 min. 38 sec. West), a distance of 199.00 feet to a point for the most southerly southwest corner of said Lot 7B from which a 5/8 inch iron rod found bears South 16 deg. 33 min. West, 0.26 feet) for corner, same being in the southwest corner of aforesaid Lot 7A;
