THENCE, North  $14^{\circ}22'38''$  West, along the west line of said Lot 2 and the east line of said Lot 1, for a distance of 186.17 feet, to a  $\frac{1}{2}$  inch iron rod found;

THENCE, North 17°31'29" East, continuing along said lines, for a distance of 8.08 feet, to a  $\frac{1}{2}$  inch iron found at the most northerly northwest corner of said Lot 2 and being in the south line of said McCartt Drive (50' R.O.W.), being on a curve to the left, having a radius of 117.60 feet, a central angle of 21°37'44";

THENCE, South  $00^{\circ}13'22"$  West, for a distance of 91.74 feet, to a  $\frac{1}{2}$  inch iron rod set with a yellow cap stamped "Corwin Eng. Inc.", on a non-tangent curve to the right, having a radius of 27.00 feet, a central angle of  $42^{\circ}49'35"$ ;

THENCE, along said curve to the right for an arc distance of 20.18 feet (Chord Bearing South  $06^{\circ}02'43''$  West – 19.71 feet), to a  $\frac{1}{2}$  inch iron rod set with a yellow cap stamped "Corwin Eng. Inc.";
