PROPERTY DESCRIPTION

TRACT I

THENCE North 30 degrees 10 minutes 29 seconds West, along the common line of said Lot 6R-1 and said Lot 9R-1, 163.13 feet to a 1/2 inch iron rod found for corner at the beginning of a curve to the left, said curve having a radius of 261.51 feet, and a chord direction of North 37 degrees 40 minutes 49 seconds West and a chord distance of 68.32 feet, and a central angle of 15 degrees 00 minutes 42 seconds;

THENCE in a Northwesterly direction along said curve to the left and along the common line of said Lot 6R-1 and said Lot 9R-1, an arc length of 68.51 feet to an "X" found for corner in a concrete drive approach at a point in said curve to the left, said point being the Southwest corner of said Lot 6R-1 and the Southeast corner of Lot 5R-1 of said addition;

THENCE North 40 degrees 05 minutes 40 seconds East, along the Southeast line of said Lot 5R-1, 78.72 feet to a 1/2 lnch iron rod found for corner;

THENCE North 59 degrees 45 minutes 26 seconds East, along the Southeast line of said Lot 5R-1, 292.95 feet to a 1/2 inch iron rod found with plastic cap for corner at the Northwest corner of said Lot 6R-1, said point also being the Northeast corner of said Lot 5R-1, said point also lying in the Southwest right-of-way line of said interstate Highway 35-E;
