T Mobile, represented by Eco Site, is proposing to build a new 100 foot tall wireless telecommunications facility. The new facility will fill a gap where indoor coverage is insufficient and reduce the 911 call burden on nearby towers. The proposed tower meets the 3:1 height to setback ratio from any single family residence. With the tower addition, an existing dumpster will be relocated and screened and additional landscaping will be added. The Planning and Zoning Commission recommended unanimous approval (6 0) of the requested SUP on February 19, 2019.

The proposed standards are updated to reflect the correct name of the department and to define acceptable restroom facilities provided at LLELA.

The Flower Mound Youth Sports Association is hosting the American Amateur Youth Baseball Alliance (AAYBA) Tournament on June 16 June 21, 2019 and June 23 June 28, 2019. Over 3,600 youth participants will participate in the tournament. A sizable portion of the event will take place at Lone Star Toyota of Lewisville Railroad Park and Lewisville Lake Park baseball complexes. Games will also be hosted at Unity Park in Highland Village and Bakersfield Park in Flower Mound and teams will rotate game locations in all three cities. The AAYBA Tournament has been held in Lewisville for the past twelve (12) years. Based on the long-standing relationship with the tournament and the economic impact a tournament of this magnitude can bring to Lewisville, a request is being made to waive up to \$31,000 in associated City fees for this event.

Attendees then enjoy a meal and hear from up to four presenters that hope to get their project funded. Projects will range from art, urban agriculture, social justice, social entrepreneurs, education, technology and more. But all presentations would be focused on ways to make Lewisville a more creative, loveable, and engaging place.

The appropriate Conflict of Interest Affidavit had been filled out and filed with the City Secretary. Mayor Durham stepped away from the dais. Mayor Pro Tem Jones took over the City Council meeting.

Consideration of Resolution No. 0114-19-RES
Amending the City's Legislative Agenda to

(Agenda Item G-15)

Two bills filed in the Texas Senate would change the eligibility requirements for a chief appraiser to prohibit any person currently holding elected office in the same county from serving in that capacity. Staff is not able to find any other example in Texas law where a person holding a specific job is denied the Constitutional right to seek and hold publicly elected office if meeting all qualifications for said office. If enacted, this legislation would deny Lewisville voters the right to select a mayor of their own choosing. The attached Resolution would amend the 2019 Legislative Agenda to add opposition to these and similar bills.

The City staff's recommendation was that the City Council consider approving the resolution as stated in the caption above.

MOTION:

Upon a motion made by Councilman Daniels and seconded by Deputy Mayor Pro Tem Troyer, the Council voted four (4) "ayes" and no (0) "nays" to approve and adopt **Resolution No. 0114-19-RES:** A Resolution of the City Council of the City of Lewisville, Texas, Amending the City's Legislative Agenda to Include Opposition to Legislation That Would Change Eligibility for a Chief Appraiser so as to Exclude Current Elected Officials From Holding the Position; Authorizing any Member of the City Council, the City Manager and the City Manager's Designee to Represent and Communicate the City's Position; and Authorizing any Member of the City Council and the City Manager to Sign all Letters, Petitions, and/or Other Documents on Behalf of the City to Promote the City's Position. The motion carried.

Councilman Gilmore stated that the way this legislation was bracketed exempts half of the entire state. He further stated that either you agree that this is some sort of issue, which it was not in his opinion, and you make it so that no one in the state can do this, or you carve it out half way. He further advised that he did not understand what Austin's point was other than to take away local control. Mayor Pro Tem Jones agreed with Councilman Gilmore's comments.

Mayor Durham returned to the dais and began directing the meeting.

Consideration of an Appointment to the Denton County Workforce Success Leadership Team

(Agenda Item G-16)

United Way of Denton County recently submitted a written request that the City of Lewisville appoint a representative to serve on the new Denton County Workforce Success Leadership Team. The purpose of this team is to increase financial capabilities and earning potential among low to moderately low income working families in Denton County. Appointees to this team will be asked to attend monthly meetings for the first year. At the conclusion of the first year, an appropriate meeting schedule moving forward will be determined by the team. Discussion held between United Way of Denton County staff and City staff have indicated that they would prefer this position to be filled by a City Council Member.

The City staff's recommendation was that the City Council consider an appointment to the Denton County Workforce Success Leadership team as stated in the caption above.

Upon a motion made by Mayor Pro Tem Jones and seconded by Councilman Gilmore, the Council voted four (4) "ayes" and no (0) "nays" to appointment Deputy Mayor Pro Tem Troyer to the Denton County Workforce Success Leadership Team. The motion carried.

Consideration of an Appointment to the Denton County Homelessness Leadership Team

(Agenda Item G-17)

The focus of the Denton County Homelessness Leadership Team (DCHLT) includes creating stronger community collaboration around community goals to end homelessness, better data collection and sharing, and educating and informing the community about solutions to homelessness and the community impact. The DCHLT is made up of representatives from Denton County, City of Denton, City of Lewisville, City of Sanger, board members from homelessness and housing providers, healthcare providers and members to the United Way of Denton County Board. The City of Lewisville appoints two members of the team (a council member and a city staff member/member of the community). Councilman Gilmore continues to serve on the DCHLT, but a vacancy now exists in the City's other appointed position. Neighborhood Services Coordinator Ashleigh Feryan has expressed an interest in serving on the DCHLT.

Consideration of an Appointment to the Denton County Homelessness Leadership Team (cont'd)

The City staff's recommendation was that the City Council consider appointment of Neighborhood Services Coordinator Ashleigh Feryan to the Denton County Homelessness Leadership Team.

Upon a motion made by Councilman Daniels and seconded by Councilman Gilmore, the Council voted four (4) "ayes" and no (0) "nays" to appoint Neighborhood Services Coordinator Ashleigh Feryan to the Denton County Homelessness Leadership Team. The motion carried.

- 2019 State of the City Video due to technical difficulties this video was not able to be viewed. City Manager Barron advised that staff would put this back on the agenda for April 1st to be viewed.
- Legislative Update Director of Communications and Tourism James Kunke gave this update.
- Mayor Durham thanked everyone that had been going to testify in Austin during the session.
- Director of Park Services advised that March 27-29 a group of nationally renowned land use, urban design and real estate experts representing the <u>Urban Land Institute</u> (<u>ULI)</u> would be visiting Lewisville to provide strategic advice on increasing access to parks and open space in an area of the city that currently lacks sufficient outdoor recreational space. This study visit was being conducted in conjunction with the 10-Minute Walk Campaign, a national movement striving to ensure that residents of urban neighborhoods throughout America have access to a high-quality park within a ten-minute walk from their homes. She advised that the kick-off meeting would be held on Wednesday, March 27th from 5:30-6:30 p.m. at Medical City Lewisville Grand Theater, 100 N. Charles and a presentation with recommendations would be held on Friday, March 29th at 9 a.m. at the Next Steps Center, 1305 TX-121 Business.
- Director of Public Services Keith Marvin gave an update on the status of the Lake.
- Director of Communications and Tourism James Kunke gave an update on upcoming events at the MCL Grand.
- Councilman Daniels stated that the staff had done a fabulous job on the St. Paddy's Day event held in Old Town.
- Mayor Pro Tem Jones wished Animal Services Manager Ethel Strother good luck in her new venture working for the SPCA.

Reports (cont'd) (Agenda Item H)

- Councilman Gilmore reminded everyone of the full-scale exercise of a disaster or homeland security-type event in order to test the City's capability to respond to a threatening situation scheduled for Friday, March 22nd from 9 a.m.- 11 a.m. He advised that there would be street closures occurring in the Old Town Area. At the request of City Manager Barron, Assistant City Manager Melinda Galler explained the process for notifying the businesses and residents that were located in the Old Town Area.

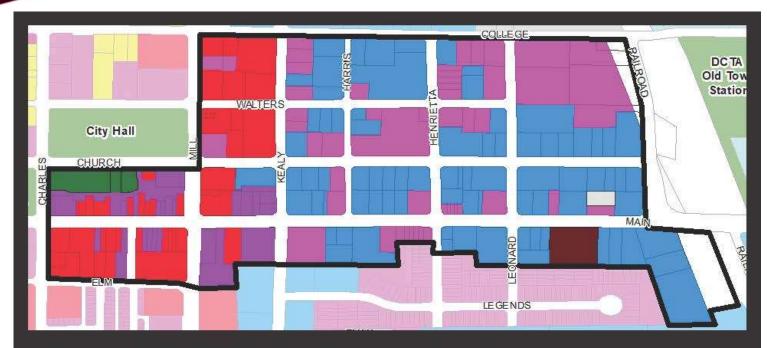

PROPOSED OLD TOWN LEWISVILLE REZONING OPEN HOUSE

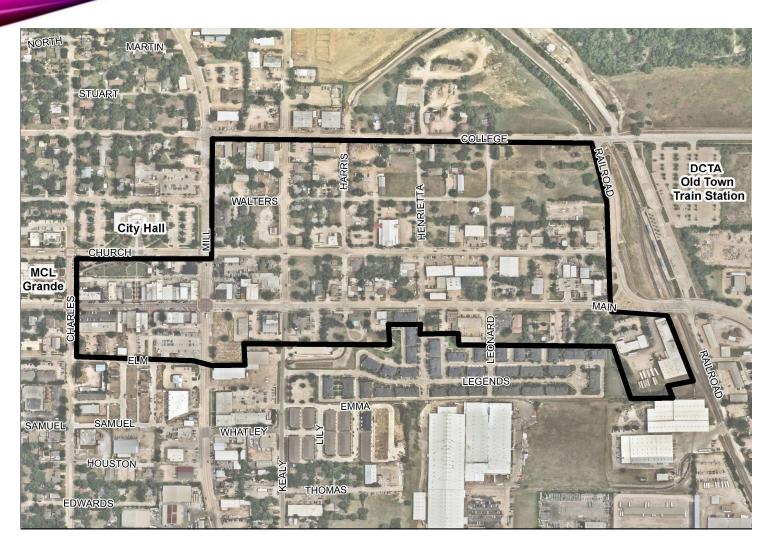

- Old Town Rezone Open House held Wednesday, November 14, 2018 from 5:00 pm to 8:00 pm at MCL Grand
 - 239 postcard invitations sent to stakeholders (property owners and tenants)
 - 19 individuals in attendance
 - Residential owners in support of rezone, which will bring residential properties into zoning compliance
 - Legal non-conforming business owner covering 2.75 acres in support of rezone, which will enhance ability to market property for redevelopment



- Additional Open House Feedback:
 - 3 warehouse owners expressed concern with loss of legal non-conforming rights after 90 days
 - Warehouse owners with Light Industrial zoning must meet current development standards if building remains vacant for one year
 - Existing warehouses in target area have little or no outside storage and are some of the more aesthetically pleasing properties in the area
 - Warehouses in TOD areas are typically considered as "blank canvases" by developers for adaptive reuse for a variety of pedestrian-oriented uses (entertainment uses, office/co-working space, creative industries, retail mix, etc.)



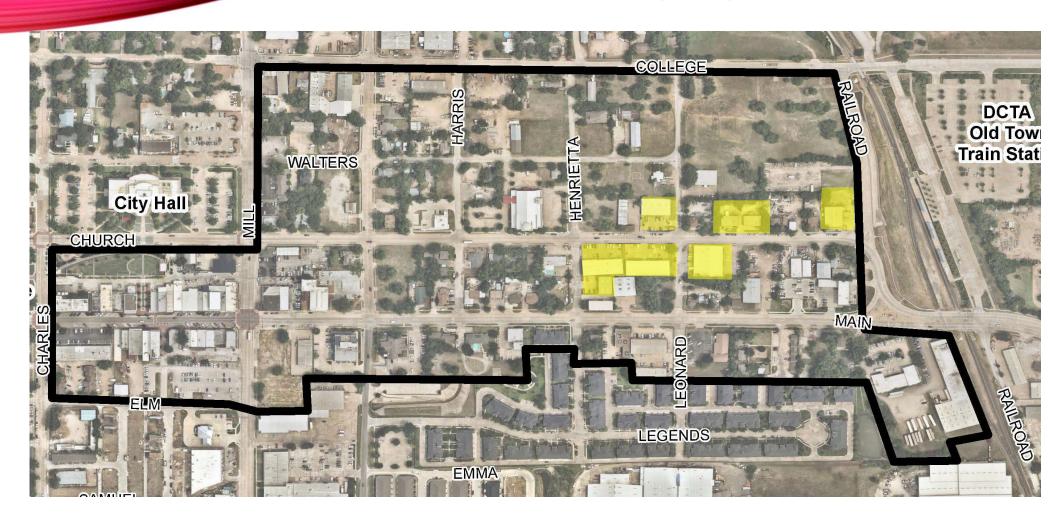
